- Candidates are instructed to deposit Application Fee by *Challan Form (available to the candidate in 3 copies, once Part-I of Online Application Form is submitted successfully)* in **any Branch of The Oriental Bank of Commerce during working hours** and obtain two copies of the Challan (Candidate's copy and University copy) with ID number from Bank after due payment of Application Fees.

(III) Submission of Form:

The Application Form shall be filled by the candidate himself / herself at the site: **<http://www.ruhsraj.org>** up to date **21/12/2013 upto 24:00 hours**. Filling the online Application Form from the above-mentioned website will not be possible after 24:00 hours on 21.12.2013 under any circumstances.

The completely filled Application Form along with required attested enclosures and original University Copy of fee deposit Bank Challan must reach the **CONVENER (Pre-PG Dental Entrance Examination-2014) Rajasthan University of Health Sciences, Sector-18, Kumbha Marg, Pratap Nagar, Jaipur - 302033 by REGISTERED POST / SPEED POST / by HAND up to 5.00 PM of 28/12/2013.**

1. Attested copy for proof of Date of Birth (Secondary School Certificate)
2. Attested copy of BDS Degree/ Provisional Certificate
3. Attested copies of Marks Sheets of BDS Professional Examinations
4. Provisional / Permanent Certificate of Registration with Dental Council
5. Certificate from DMHS, Jaipur or Principal Medical / Dental College in the prescribed form for In-Service candidates only
6. Attested copy of Internship completion/pursuing certificate.
7. Attested copy of the Caste Certificate from competent authority for SC/ST, OBC/SBC category (creamy / non-creamy).
8. Attested Certificate of lower locomotor disability duly signed by Govt. Medical Board on prescribed form.
9. Original University copy of fee deposit Bank Challan.

A candidate should fill only one form. All Annexures must be properly tagged with the Application Form.

No Application Form will be accepted after 5.00 PM of 28/12/2013. RUHS, Jaipur will not be responsible for any postal delay. Incomplete Application Forms / incomplete attested enclosures with the Application Form will not be considered and shall be liable to rejection.

Information Booklet for the Pre-PG Dental Entrance Examination-2014 (For admission to MDS Courses)

Rajasthan University of Health Sciences will conduct Pre-PG Dental Entrance Examination – 2014 for admission to MDS courses in Govt. Dental Colleges of Rajasthan on Sunday, 19 January, 2014. Candidates eligible as per Ordinance 278-E & 278-G of Rajasthan University as modified and adopted by Rajasthan University of Health Sciences, Jaipur are required to appear in the aforesaid Online Examination for seats mentioned in 1(b) below.

1. Seats and Reservations

- a. 50% of the total seats available in various MDS courses will be filled in as per allocations made by the Director General of Health Services, Government of India, New Delhi, on the basis of the result of All India Competitive Entrance Examination for admission to P.G. Courses (MDS) on open merit, as per directions of Hon'ble Supreme Court of India.
- b. Remaining 50% of the total seats available in various MDS courses will be filled in on the basis of merit in the Pre-PG Dental Entrance Examination - 2014. Out of these seats allotment to In-Service and General (Non-Service) candidates would be as per Ordinance 278-E & 278-G of University of Rajasthan as modified and adopted by Rajasthan University of Health Sciences, Jaipur. Further distribution of seats shall be as per rules and regulations of Dental Council of India (DCI) and directives of State Govt./ Hon'ble Court in this regard.

2. Eligibility for Admission

A. Applicable to In-Service Category :-

Candidates seeking admission to M.D.S. Courses should be in service of State Government of Rajasthan and below the age of 45 years as on 30.04.2014 and should have:

1. Obtained BDS qualification from Dental College recognized by DCI.
2. Completed satisfactorily one year's compulsory rotating internship.
3. Obtained registration from Dental Council (Provisional or Permanent).
4. Secured at least 50% marks (40% in case of natural born SC/ST, OBC/SBC non-creamy and 45% in case of lower locomotor disabled candidates) in the Pre-P.G. Dental Entrance Examination 2014.
5. Completed or likely to complete at least THREE years of Govt. service in the Govt. of Rajasthan as on 30-4-2012.

The candidates would be required to submit a certificate (Format enclosed with the form) to above effect duly signed by the Director, Medical and Health Services, Government of Rajasthan, Jaipur or Principal, Govt. Medical / Dental College, Govt. of Rajasthan, Jaipur failing which his/her application will not be considered.

B. Applicable to Non-Service Category :-

Candidates seeking admission to M.D.S. Courses should have passed Final B.D.S. Examination from the University of Rajasthan / Rajasthan University of Health Sciences and should have:-

1. Completed satisfactorily one year's compulsory rotating internship or would be completing the same upto 30th April, 2014 after passing the Final BDS Examination. No condonation of compulsory rotating internship shall be accepted
 2. Obtained registration from Dental Council (Provisional or Permanent). Candidates registered with any other Dental Council are required to submit RDC Certificate at the time of admission.
 3. Secured at least 50% marks (40% in case of natural born SC/ST, OBC/SBC non-creamy and 45% in case of lower locomotor Disabled Candidates) in the Pre-P.G. Dental Entrance Examination 2014.
- For claiming reservation and relaxation under SC/ST, OBC/SBC non-creamy Category, candidates are required to submit an attested copy of Caste Certificate issued by Competent Authority. SBC/OBC Category Certificate should be issued within last six month (i.e., after 19th July 2013) OBC/SBC non-creamy category candidates will get relaxation. OBC/SBC creamy category candidates will not get relaxation.
 - For claiming reservation under Disabled category, candidates are required to produce a Certificate of lower locomotor disability certificate in prescribed form duly signed by Medical Board constituted for this purpose.

3. Other Conditions for Pre-PG Dental Entrance Examination 2014

- a. *Candidates are advised to read information booklet and Instructions for filling on-line application form carefully before starting Online Registration. **In the event of rejection of application, no correspondence / request for reconsideration will be entertained.***
- b. Online Application Form consists of two parts and shall be filled by the candidate himself / herself from the following site: **<http://www.ruhsraj.org>** up to date **21/12/2013**.
- c. Candidates are instructed to deposit Application Fees by *Challan Form (available to the candidate in 3 copies, once first part of the Online Application is submitted successfully)* in **any Branch of The Oriental Bank of Commerce in working hours** and obtain two copies of challan (Candidate's copy and University copy) with ID number given by the Bank, after which the applicant needs to fill second part of Online Application.
- d. Application Fee once deposited will not be refunded in any case.
- e. A candidate is required to fill only one application form.
- f. Candidate must write the ID number given by the bank on the printed copy of the Application Form and attach University copy of challan along with hard copy of Application Form.
- g. The completely filled Application Form along with all attested enclosures and original University copy of fee deposit challan must reach the **CONVENER (Pre-PG Dental Entrance Examination-2014) Rajasthan University of Health Sciences, Sector-18, Kumbha Marg, Pratap Nagar, Jaipur - 302033 by REGISTERED POST / SPEED POST / by HAND up to 5.00 PM of 28/12/2013.**
- h. RUHS, Jaipur will not be responsible for any postal delay. No application form will be accepted after 5.00 PM of 28/12/2013. Incomplete Application Forms / incomplete attested enclosures with Application Form will not be considered. The

candidates must ensure the delivery date from post office and should send their form well in advance.

Caution: Candidates must ensure that all required Annexures duly attested are enclosed and properly tagged with Application Form. Any loose Annexure should not be submitted with the form.

- i) Furnishing of false information or suppression of material information in the Application Form will entail **disqualification** and shall render the candidate unfit for admission. If ineligibility is detected at any stage, the candidature/ admission will be treated as cancelled. No further correspondence in this regard will be entertained. Further intimation in this regard will be sent to MCI/DCI/State Medical Council/ State Dental Council, concerned Medical / Dental College for necessary action.
- j) Any correction in or submission of Annexures after submission of Application Form will not be entertained.
- k) **Instructions for Photograph:** The candidate is required to get his/her recent (taken on or after 01.7.2013) colour passport size photograph (front face) with name of candidate as in application and date of taking photograph. The photograph should be pasted, not to be stapled or pinned. Polaroid photograph is not acceptable. The Application Form should be duly attested by the Principal of Medical College / Gazetted Officer or Director of Medical & Health Services and the candidate must give his / her both (right & left) thumb impressions, failing which his / her Admit Card will not be released. At the time of Online Examination, in addition to the Admit Card, the candidate has to bring a spare photograph identical to that uploaded in Application Form. The candidate must write his / her Name and Roll No. on the back side of the photograph and hand it over to the Invigilator.

The Online Examination will be held **on 19-01-2014 at Jaipur only**. Candidates are required to come at least two hours before the commencement of the examination for security purposes, personal verification, etc.

4. Details of Examination

The Online Examination will be held on 19-01-2014 at Jaipur only.

- a. The Pre-P.G. Dental Entrance Examination 2014 shall be of the standard of B.D.S. Examination of Rajasthan University of Health Sciences and shall cover all the subjects of the B.D.S. Course.
- b. There shall be two sections, each containing 100 multiple choice questions. Subject-wise distribution of questions is given below:

- c. Paper will be online, of three hours duration.
- d. The allotment of Center, Roll No. and seating arrangement will be at the discretion of the University.
- e. *The candidates should report at the examination center two hours before commencement of the examination.*
- f. Candidate will be required to produce **Admit Card, Photo Identity Card and a spare photograph** before he / she is allowed to enter the Examination Centre.
- g. No candidate will be allowed to carry any text material, written or printed, bits of paper or any other material inside the hall. Wrist Watch / Pen / Pencil / Paper / Mobile Phone / Pager / Calculator / Laptop / Palmtop / Bluetooth or any electronic gadgets etc. are strictly prohibited in the Examination Hall. Candidates should not bring text books/Mobile or any other material to the Examination Center. **No arrangements have been made at the centres for their custody.**
- h. The Online Examination shall be conducted in **ENGLISH** medium only.
- i. **No candidate will be allowed to go outside the Examination Hall till the completion of the examination.**
- j. All questions will be of objective type single correct answer. Each answer with correct response shall be awarded **four marks**. **Zero mark** will be given for wrong answer or question not answered. **There will be no negative marking.**
- k. In case of any legal dispute, the jurisdiction shall be limited to competent Courts at Jaipur only.
- l. Admit Card will be available for printing to all the eligible candidates, on the official website of RUHS.

5. Declaration of Results

Result will be prepared on the basis of data obtained from Online Examination. Separate Merit List of qualifying eligible candidates will be prepared for each category. In case of two or more candidates obtain equal marks in the examination, the *inter se* merit of such candidates shall be determined in order of preference as under:-

1. Candidate obtaining higher marks in Section-II shall be placed above the candidate obtaining lesser marks therein.
2. In case (1) above does not apply then according to age, older will get preference over younger.
3. If, after applying criteria (1) and (2) above, the merit of two or more candidates is at par, then the number of attempts for passing Final MBBS examinations will be considered. The candidate with lesser number of attempts for passing Final MBBS examinations will get preference over the other.
4. Even after applying criterion (3), if the merit of two or more candidates is at par, then the aggregate marks of the candidates in Final MBBS examinations will be considered. The candidate with higher aggregate marks in Final MBBS examinations will get preference over the other.

Result of the Pre-P.G. Dental Entrance Examination will be displayed on the official website of RUHS.

There is no provision for rechecking/re-evaluation and no query in this regard will be entertained.

6. Details of Counselling

Details of counseling would be available in due course.

7. Important Points

- a. **Impersonation:** If, during the Examination or Counselling, it is found that a candidate has indulged in any case of impersonation i.e. the photograph / signature / document of the candidates are not matching etc., he/ she will be handed over to the Police and cases will be dealt as per Indian Penal Code in the matter. Such candidate will be debarred permanently from taking Pre-P.G. Dental Entrance Examination in future. A recommendation will also be made to Medical Council of India to strike their names off from the Medical Register.
- b. Candidate should enter the information in the Online Application Form very carefully. Before submitting the Online Application Form, a hard copy should be taken and checked by candidate carefully. Information in Online Application Form will be final. No amendment / change will be allowed in the printed copy manually. Candidate should not enclose any request for change in information.
- c. **The Application Fee is non-refundable in any case.** Therefore, all candidates are advised to ensure their eligibility before submitting the Application Form. Candidates whose internship after passing Final M.B.B.S. Examination is not expected to be completed up to **30-4-2014** are not eligible to appear in the Pre-P.G. Dental Entrance Examination 2014 and their Application Forms will not be entertained.
- d. It should be carefully noted that if the required documents / certificates duly attested are not attached, the Application Form will be rejected without any notice.
- e. The Certificate to be submitted by 'In-Service' candidates should clearly indicate that, as on 30-4-2014, the person concerned has served Government of Rajasthan for at least three years in rural area or two years continuously in the desert / hilly / tribal areas of the State of Rajasthan where rural allowance was admissible to him / her, failing which the Application Form will be rejected. No addition / alteration shall be allowed to be made on the prescribed certificate at a later stage.
- f. For In-Service candidates, the candidates are required to submit **two hard copies** of filled, printed Application Forms – one (**advance copy**) directly to the Convener, Pre-PG Dental Entrance Examination 2014, Rajasthan University of Health Sciences, Sector-18, Kumbha Marg, Pratap Nagar, Tonk Road, Jaipur – 302033 (along with original University copy of fee deposit Bank Challan Form) and another to Directorate of Medical and Health Services, Government of Rajasthan, Jaipur (through CMHO / PMO / Principal & Controller of Medical College as applicable) latest by 5:00 PM of 28.12.2013. The candidate must send second hard copy of Application Form with all Enclosures to Director (Public Health), Directorate of Medical and Health Services, Government of Rajasthan, Swasthya Bhawan, Tilak Marg, C-Scheme, Jaipur (after obtaining Experience Certificate from CMHO / PMO / Principal Medical / Dental College as applicable). *Candidates applying for In-Service category should ensure their eligibility prior to filling the Application Form. There is no option for changing the category.*
- g. Director Medical & Health Services, Government of Rajasthan shall submit a certified list of 'In-Service' eligible candidates directly to Convener, Pre-PG Entrance Examination.
- h. Successful candidates after first Counselling or subsequent Counselling will have to submit Bank Guarantee of Rs. 1.50 Lakhs and a Bond of Rs. 3.50 Lakhs (*Candidates belonging to BPL Family are required to deposit a Bond of Rs. 5.00 Lakhs only*) at the time of joining / reporting at allotted College so

that he / she cannot forgo or leave the course or seat after the scheduled last date of admission / joining. If he / she does, the Bank Guarantee will be forfeited. Successful candidates are required to execute a Bond to the effect that he / she will not resort to Strike or Mass C.L.

- i. **Candidates are advised to see the website of RUHS www.ruhsraj.org regularly for all additional information / notifications.**
- j. In case of any legal dispute, the jurisdiction shall be limited to competent Courts at Jaipur only.

INSTRUCTIONS

1. The Pre-P.G. Dental Entrance Examination will be conducted at Jaipur only. All candidates are required to appear at the Pre-P.G. Dental Examination at their own expenses.
2. The examination will be online on Sunday, 19th January, 2014.
3. Candidates are requested to reach at Examination Centre two hours before the scheduled time of commencement of the Online Examination for security reasons, personal verification, etc.
4. No candidate shall carry any text material (written or printed), bits of paper or any other material inside the hall. Wrist Watch / Pen / Pencil / Paper / Mobile Phone / Pager / Calculator / Laptop / Palmtop / Bluetooth or any other electronic gadgets etc. are strictly prohibited in the Examination Hall. Candidates should not bring text books / Mobile or any other material to the Examination Center. No arrangements have been made at the centers for their custody.
5. The candidate shall maintain silence and attend to his / her paper only. Any disturbance by the candidate at the site of Online Examination will be deemed misbehavior and the candidate involved in such activity shall forfeit his / her right to continue in the Online Examination. The decision of the Centre Superintendent shall be final and conclusive in the matter.
6. No candidate shall be allowed to go outside the Examination Hall till the completion of the Online Examination.
7. Writing anything on the Admit Card or any stray paper will be treated as unfair means.
8. Kindly also carefully read the Instruction Booklet attached with the Application Form before coming to the Examination Centre.
9. Candidates have to preserve the Admit Card till allotment of seat and final admission in the College / Institute. Duplicate Admit Card will not be issued after the Online Examination.
10. This Admit Card is subject to the condition that if ineligibility is detected at any stage, the candidature will be cancelled. Please check the particulars in the Admit Card carefully. Errors, if any, should be immediately reported to the Section, Rajasthan University of Health Sciences, Jaipur.
