And must not be above 32yrs of age on 01.01.2014, the upper age limit is relaxable by 5rs in case of S.C. /S.T. & Women, 3yrs. in case of S.E.B.C. candidates and 10yrs. in case of Orthopedically handicapped candidates.

3. Method of Selection.

Selection of the candidates shall be made from a merit list to be prepared on the basis of career marks obtained i.e. 40% in the H.S.C. plus 60% marks obtained in +2 science or equivalent qualifications.



The Deputy Director of Horticulture, Ganjam, Berhampur invites application from eligible candidates for engagement as Horticulture Extension Workers (H.E.W.) on contractual basis in the Revenue District of Ganjam.

1. Educational qualification

A candidate must have passed +2 science or equivalent qualification from a recognized University or Institution

2. Age limit

The candidate applying for the post of H.E.W. must have attained the age of 21yrs. And must not be above 32yrs. Of age on 01.01.2014, the upper age limit is releaxable by 5rs. In case of S.C. /S.T. & Women, 3yrs. in case of S.E.B.C. candidates and 10yrs. in case of Orthopedically handicapped candidates.

3. Terms and conditions

A candidate shall be

- a. A citizen of India and permanent residence of Orissa.
- b. Of Good moral character, good physique and free from organic defect
- c. Must be able to speak , read and write Oriya and shall have passed a test in Oriya equivalent to M.E. school standard or shall have passed Matriculation or equivalent examination with Oriya as medium of examination in non-language subject or passed M.E. School standard.
- d. The selected candidate will be engaged on contractual basis for a consolidated remuneration of Rs.5200/-plus Grade Pay per month and will under go in service training for one year and they shall have to appear in two semester examination. Minimum pass mark in the training shall be 50% in aggregate.
- e. The candidate engaged on contractual basis shall not claim for regularization of their service either during the period of their engagement of after its termination.

4. Method of Selection.

Selection of the candidates shall be made from a merit list to be prepared on the basis of career marks obtained i.e. 40% in the H.S.C. plus 60% marks obtained in +2 science or equivalent qualifications.

There is no specific reservation for men under any category. The fact that a certain nos. of seats are reserved for women does not mean that the remaining seats are reserved only for men.

The reservation are applied considering the whole State as a unit at present 1% of post of H.E.W. to be kept reserve for physically handicapped candidates as per G.A. Department Regulation No. 3404/G.A. dt. 13.02.2006 and such reservation will be applied to only those orthopedically handicapped candidates who fall in OA and OL(MNR) categories as defined in the resolution.

6. Documents to be submitted.


The copies of the following documents dully attested by a Gazetted officer not below the rank of Class-II (Group-B) and signed by the candidates shall be attached with application form.

- a. H.S.C. examination or equivalent certificate in support of age and date of Birth.
- b. Certificate in support of passing +2 science /or equivalent .
- c. Mark sheets in support of qualifying examination (H.S.C. examination or equivalent and +2 science /equivalent).
- d. Caste certificate from competent Revenue Authority in case of S.C./S.T./S.E.B.C. candidates.
- e. Character certificate from two Gazetted Officer (Group -B) not below Class-II.
- f. Certificate of good conduct from the Institution in which he/she last studied.
- g. If employed no objection certificate from the employer is to be submitted.
- h. Two copies of attested pass port size recent photographs.

7. Last date of submission of application.

The candidates fulfilling the above requirement should apply by Regd. Post or in person in the prescribed format available in the office of the Deputy Director of Horticulture, Ganjam, Berhampur/Assistant Director of Horticulture, Chatrapur/Bhanjanagar and to submit with required documents as indicated above only to the Deputy Director of Horticulture., Ganjam, Berhampur by 5.00 P.M. of 05.02.2014 A candidate can apply for only one District in the State.
