
In continuation of this Ministry's letter of even no. dated 26.02.2014 on subject cited above, **I am directed to state that No objection certificate (N.O.C.) from Election Commission of India for issue to advertisement for Pre-matric Scholarship Scheme has been obtained.** It is requested that necessary action may be taken for issue of advertisement and other subsequent activities for award of Pre-matric Scholarships for students belonging to minority communities as per the **revised activity timeline** enclosed. Community-wise Physical targets for the States/UTs will remain unchanged.

2. The State Governments/ UT Administrations are also advised to furnish the status of disbursement of scholarships released in the year 2013-14 to this Ministry. States/ UTs are required to upload the list of students who have been awarded scholarships alongwith requisite detail on their websites hyperlink with this Ministry's website *viz* www.minorityaffairs.gov.in. **Publishing/Uploading the list of scholarship awardees on the website of Ministry of Minority Affairs has been made mandatory.** Those States/UTs, who do not upload the list of students awarded scholarships in 2013-14 on their website, shall not be considered for release of Scholarships in 2014-15.
