#### 1.DEIC Manager

- Planning and Organization of DEIC with transdisciplinary approach.
- To serve as a liaison with health and other departments.
- To establishing linkage with Block level officials or stake holder departments.
- Submit the monthly report to NRHM HQ.
- · Prepare expenditure sheets and keep accounts of DEIC updated.
- Review the data and do monitoring and evaluation with support from data entry operator.
- Monitor referred cases from ASHA, health facilities and Mobile health teams under RBSK.
- To provide assistance in policy research/review related to RBSK in the district.
- Planning & monitoring the monthly/quarterly meeting with Mobile Health Teams for smooth running the program.
- · To resolve any issues regarding working of DEIC.
- · Research & Development

#### 2. EARLY INTERVENTIONIST CUM SPECIAL EDUCATOR

- To provide therapy to children with developmental delays related to early intervention
- Proper maintain all the tools & equipment in DEIC.
- To assist the team member in confirming and managing the developmental delays and disabilities
- To fully focus on the therapy of the children and not on the adults
- To council the parents regarding the condition of the child.
- To facilitate the referred children for assessing the referral services.
- To teach the parent regarding Home Based Therapy for the child.
- To ensure the functionality of equipments in the DEIC.
- To collaborate with other clinical disciplines in terms of comprehensive patient management.

#### 3. AUDIOLOGIST AND SPEECH THERAPIST

- To work as a team with other staff member of DEIC.
- To provide therapy to children with developmental delays related to speech, language and hearing.
- To assist the team members in confirming and managing the developmental delays and disabilities.
- To fully focus on the therapy of the children and not on the adults.
- To counsel the parents on home therapy for the child.
- To ensure functionality of equipments in the DEIC.
- Collaborates with other clinical disciplines in terms of comprehensive patient management.
- Refer to DH who will determine the appropriate choice of medical and/or surgical intervention, if required.
- To coordinate hearing screening programme development, management, quality assessment and service coordination.
- To provide audio logical diagnosis, treatment and management including appropriate referral and documentation.
- To provide comprehensive audio logic diagnosis assessment to confirm the existence of the hearing
  loss
- To inform the parents regarding the hearing screening result, impact of the hearing loss and rehabilitation.

- To evaluate the infant before selecting him/her as a candidate for amplification, other sensory devices and assistive technology and ensure prompt referral for early intervention programs.
- To ensure that hearing-screening information is transmitted promptly to the primary healthcare facility and appropriate data are submitted to the screening committee.
- To provide information to parents on normal language development.
- To administer ongoing formal and informal diagnostic assessment, to develop individualized therapy plans, to monitor progress and to evaluate the effectiveness of the plan for the child and family.
- To guide and coach parents to become the primary facilitators of their child's listening and spoken language through active consistent participation in individualized therapy sessions.
- To guide and coach parents to help the child integrate listening and spoken language into all aspects
  of the child's life, by creating environments that support listening for the acquisition of spoken
  language through the child's daily activities to ensure comprehensive speech & language therapy.

# 4.OCCUPATIONAL THERAPIST/ PHYSIOTHERAPIST

- To provide therapy to children with developmental delays in the motor area.
- To assist the team member in confirming and managing the developmental delays and disabilities.

#### 5. MEDICAL OFFICER, DENTAL

- Diagnosis and treatment of the Oro- dental ailments.
- Provide preventive & restorative treatment for oral health problems.
- Educating the patient & parents regarding Oral healthcare.
- To monitor the general health, development, and well-being of the child.
- · To ensure and support the continuity of care.
- To treat all children referred with dental ailments.
- To counsel patients or parents.
- To include awareness on aspects of oral health within the broad framework of maternal child health program.
- To ensure that the data collected from periphery and from DEIC should be sent to the district and state authorities timely.
- To extend supportive supervision to Block Health teams to avoid unnecessary referrals and handholding.
- Collaborates with other clinical disciplines in terms of comprehensive patient management.
- To coordinate and facilitate parents" support group activities.

### 6. MEDICAL OFFICER, MBBS

- To monitor the general health, development, and well-being of the infant.
- To review medical and family history for the presence of associated risk factors.
- To ensure and support the continuity of care.
- To initiate referrals for medical specialty evaluations necessary for treatment.
- To monitor development at 6, 9, 12, 18 and 24 months of age.
- To counsel patients or parents.
- To include awareness in the maternal child health program related to 4 Ds.
- To ensure that all high risk newborns are included in the high risk neonatal hearing screening program.
- To ensure all high risk newborns are included in the screening program for developmental delays.

#### 7.PEDIATRICIAN

- · Health education (e.g. brochures, pamphlets, posters, electronic Information about developmental delays, role of early interventions especially to avoid developmental disability including hearing screening for all newborns born at DH etc).
- To identify the babies who are referred from periphery, advice confirmatory tools and initiate appropriate screening, timely intervention and referral to higher centre, if required.
- To screen self-referral cases due to family concerns, advice screening and confirmatory tools, timely intervention and referral to higher centre, if required.
- To monitor the hearing and speech development of newborns born at district hospital/ admitted in
- To ensure and support the continuum of care of the children identified.
- To initiate referrals for other medical specialty necessary to determine the presence and etiology of the health conditions.
- To determine any other associated medical conditions.
- Counseling services.
- Fulfills duties as Technical in-charge of DEIC
- To extend supportive supervision to Block Health teams to avoid unnecessary referrals and handholding.

#### 8. PSYCHOLOGIST

- Work for the bipolar disorder, Neurological disorder, Learning disability and personal & family relationship problem.
- Provide comprehensive health care (Mental & behavioral) services for the prevention and treatment of mental disorder and behavioral health conditions.
- Utilize intervention such as Psychotherapy, behavioral technique, and biofeedback to help individuals make behavior change (eg. Medication, Diet, Exercise) and develop coping strategy (e.g. Chronic pain management) to reduce problems that is residual to the patient's illness or disorder (e.g. cardiovascular diseases).
- Teach patient the skills necessary to enhance physical and mental well being.

#### 9. STAFF NURSE

- Anthropometric measurement and case record management.
- Nursing care of the children.
- Assist DEIC Manager in generating reports, conducting capacity building events.

#### 10. LAB TECHNICIAN

- To work as a team with other staff member of DEIC.
- To assist the team members in confirming and managing the developmental delays and disabilities.
- To ensure functionality of equipments in the DEIC.
- Collaborates with other clinical disciplines in terms of comprehensive patient management.
- Work in close tandem and schedule with lab technician sanctioned under FBNC op guidelines posted at SNCU. Provide 24 hour (round the clock) lab support including newborn screening, referral from the periphery for hematological investigations in children.

#### 11. DENTAL ASSISTANT

- Providing assistance in the office with tasks such as appointment scheduling, record keeping, telephone management, and billing accounting, and money management
- Seating patients in the treatment area and escorts patients to the operatory.
- Maintain a sterile and neat working environment according to current infecting control program.
- Sterilization and preparation of instruments
- Passing requested instruments to the dentist during dental procedures. Assists the dentist in the administration of treatment at the chair side as required or directed by the dentist.
- Assist the dentist directly at chair side with operative, oral surgery, orthodontic, and a wide range
  of other procedures
- · Handling instruments and suctioning.
- Taking impressions of teeth for study models
- Polishing clinical crowns.
- Exposing and developing x-rays
- Provide oral hygiene instructions, preventive dentistry & dietary counseling.
- Familiar the patient with the aspects of their dental visit and provide support and compassion to that patient when it is needed.
- Stock operatories and maintain clinical supply inventory.
- Review daily schedule to set up appropriate trays and instruments.
- · Greets patients in waiting area and escorts patients to the operatory.
- Promotes an atmosphere supportive of good dental and general health by demonstrating good oral
  hygiene, questioning patients to ascertain home care status, instructing patients in techniques of
  flossing and brushing in accordance with protocol.
- Review the health history, make chart entries under the direction of the operator and assure completion of forms and signatures.
- Assume the responsibility associated with any expanded duties that may be delegated by the
  dentist.

#### 12. SOCIAL WORKER

- They maintain professional relationships with service users, acting as guides, advocates or critical friends.
- · Arranging appropriate care, resources or benefits.
- Assessing, counselling and offering advice to clients.
- Liaison with relatives, colleagues and other professionals for providing benefits to children.

#### 13. OPTOMETRIST

- Routine vision checkup/ glaucoma screening for referring children.
- Prescribe eye glasses/contact lenses.
- Refer the patient having eye disorder/diseases
- To work closely under the supervision of an ophthalmologist

## Following roles are common to the above mentioned posts:-

- To work as a team with other staff member of DEIC as a member of a trans disciplinary team.
- To maintain all the tools & equipment related to concerned department where posted in DEIC.
- To fully focus on the therapy of the children and not on the adults.
- To counsel the parents regarding the condition of the child.
- To teach the parents regarding home based therapy for the child.
- To ensure the functionality of equipments in the concerned department of DEIC.
- To collaborate with other clinical disciplines in terms of comprehensive patient management.
- To provide social and emotional support to parents whose children have been confirmed with developmental delays and disability.
- Assist DEIC Manager in generating reports, conducting capacity building events.
- · Record Keeping.
