BHABHA ATOMIC RESEARCH CENTRE (BARC) invites on-line application for the following Group 'A' Gazetted posts as follows:

Name of the Post	: Medical Officer (Nuclear Medicine) in the grade of Scientific Officer (D)
No. of posts	: Three (03)
Qualification	: MD (Nuclear Medicine) or DNB (Nuclear Medicine) or MD in Radiotherapy with DRM/DNM or MD in Radio-diagnosis with DRM/DNM or MD in Biophysics with DRM/DNM.
Nature of duties	: 1. Clinical Nuclear Medicine Services: (a) Management of patients with thyroid diseases using diagnostic and therapeutic nuclear medicine procedures; (b) Advice, supervise & prepare report for in vivo nuclear medicine scans including SPECT & PET imaging; & (c) Radionuclide Therapies : As a Nuclear Medicine Physician he/she should be well versed with therapies using isotopes. 2. Research & Development & Teaching : The selected officer shall be assigned to on-going R&D projects and he/she will also take part in the teaching programmes for nuclear medicine and nuclear medicine technology courses conducted at our Institute.
NOTE: Candidates with 4 years experience after MD/DNB will be considered for appointment as Scientific Officer/E. Exceptionally brilliant candidates can be considered even with two years of experience. The maximum age limit for the post of SO/D is 40 years. However, candidates with 4 years experience after MD/DNB and have maximum age limit of 45 years can also apply.

Qualification & Experience	: MBBS with one-year institutional experience. Mandatory internship shall not be counted as experience. Candidates with Post Graduate qualification and equivalent need not apply.
Desirable	: Candidates with Casualty experience and worked as GDMO/General Practice will be preferred.
Nature of duties	: 1) Attending to patients of all age groups & providing health care at the periphery level. 2) Attending to routine ailments, chronic cases like Diabetes mellitus, Hypertension, Ischemic Heart Disease, Tuberculosis, epilepsy etc.;

- 3) Follow-up of patients with chronic illnesses with regular monitoring & reference to hospital as and when required.
- 4) Management of emergencies at dispensary and after stabilization referring to hospital if necessary.
- 5) Data Entry in computer, including Generated case notes, diagnosis, online prescription, creating Service Order, Appointments etc.

(c)	The candidates may download a copy of the application and admit card and submit the same along with the attested copies (<i>duly attested by a Gazetted Officer</i>) of all relevant documents in support of date of birth, educational qualification (certificates & mark sheets), caste, experience only at the time of interview. <u>Candidates who report for the interview without any of the supporting documents will not be allowed to appear before the interview committee.</u>
(d)	The facility of online application will be opened from 25/02/2014 to 21/03/2014.
2.	In case of huge response to any post, the screening will be restricted to those with higher percentage of marks and more experience or a screening test of the eligible candidates will be conducted in order to shortlist the candidates to be called for the interview.
3.	Candidates will be called for technical interview based on their academic and professional qualifications and experience in the relevant field. Final selection will be based on the performance in the interview.

4.	Selected candidates, on their appointment, will be governed by the New Contributory Pension Scheme.
5.	Reservation as per rules will be applicable. Benefit of reservation is applicable for the persons with disabilities (40% and above) as detailed below : For the post of Category No. II (01 PH):– One leg affected(OL)/One Arm affected (OA)/ Partially Deaf(PD)]
6.	Selected candidates are liable to be posted to any of the Units of BARC located in India or to a part of India in the Constituent Units of Department of Atomic Energy.
7.	The candidates called for interview from outstation will be paid to and fro rail fare by SECOND CLASS/ SLEEPER or actual fare whichever is less.
8.	Age limit is relaxable by 5 years for regular Government servants working in posts which are in the same line. For Category No. IV, age limit is relaxable by 5 years for ST candidates and 3 years for OBC candidates not belonging to creamy layer and for Category No. II, age limit is relaxable by 5 years for Physically Handicapped candidates.
8(a)	SC/ST/OBC certificate should be as per the prescribed format, for employment in Government of India.

Relaxation in the upper age limit of 5 years shall be admissible to all persons who had ordinarily been domiciled in Kashmir division of the state of Jammu & Kashmir during the period from the 1 st day of January 1980 to 31 st day of December, 1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules.
9(a)	Certificate regarding proof of residence – any person intending to avail of this relaxation of age limit admissible under rule 3 shall submit a certificate from: <ul style="list-style-type: none"> a) the Dist. Magistrate in the Kashmir division within whose jurisdiction he had ordinarily resided; or b) any other authority designated in this behalf by the Government of Jammu & Kashmir to the effect that he had ordinarily been domiciled in the Kashmir division of the state of Jammu & Kashmir during the period from the 1st day of January, 1980 to the 31st day of December, 1989.
9(b)	Relaxation in the upper age limit of 5 years shall be admissible to children/family members of those who died in the 1984 riots.
10.	BARC reserves the right to reject or accept the candidature of any applicant at any stage.
11.	BARC reserves the right to cancel/restrict/enlarge/modify/alter the recruitment process, if need arises, without issuing any further notice or assigning any reason therefore.
12.	The vacancies shown above are provisional and subject to variation. The filling up of vacancies indicated in the advertisement is also subject to the approval of Competent Authority and may not be filled up if decided otherwise in terms of the orders issued by Govt. of India from time to time. In addition to the vacancies indicated in this advertisement, the future vacancies and also vacancies in other units of DAE, which may arise after formation of the panel, will also be filled from the waitlist panel prepared from this advertisement till the validity period of the panel.
13.	Candidates may ensure that they fill in the correct information. Candidates who furnish false information will be disqualified for screening test/interview.

Candidates belonging to SC/ST, dependents of defence service personnel killed in action, persons with physical disability and women candidates are exempted from payment of this fee.
