The candidates are required to submit application fee in the shape of crossed Indian Postal Order/Demand Draft in favour of *Registrar General*, *High Court of Himachal Pradesh*, *Shimla* payable at Shimla. The fee for Class-III posts is `200/- for General Category, `150/- for reserved category and such fee for Class-IV posts is `150/- for General Category, `100/- for reserve category.
- 3. Applications received after due date or incomplete applications, or not in accordance with the prescribed format, shall be out-rightly rejected and no correspondence will be entertained in that respect.
