

TERMS AND CONDITIONS - CAR DHAMAAL COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "CAR DHAMAAL COMPETITION". BY PROCEEDING WITH PLAYING THE CAR DHAMAAL COMPETITION, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS AND THE VODAFONE COMPETITION PACK TERMS AND CONDITIONS WHICH SHALL BE DEEMED TO BE INCORPORATED HEREIN ("Terms And Conditions"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE CAR DHAMAAL COMPETITION.

- 1. "Car Dhamaal Competition" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India ("OnMobile" or "Organizer") and is open for subscription to active¹ pre-paid and post-paid category of Subscribers² ("Subscribers") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter referred to as "Vodafone India") is launched as part of the Vodafone Competition Pack (hereinafter referred to as "Competition Pack") and is open during the period from 25th September 2013, 00:00:01 hrs to 23rd November 2013, 23:59:59 hrs (hereinafter referred to as the "Competition Period"). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit, and any such change shall be published on the website, http://vodafone.contestzone.in and www.vodafone.in ("Website").
- 2. The Competition is open for all Subscribers who satisfy the eligibility criteria mentioned below and who belong to the following Vodafone India telecom circles ("Circles") of ANDHRA PRADESH, ASSAM, BIHAR, DELHI, GUJARAT, HARYANA, HIMACHAL PRADESH, KARNATAKA, KERALA, KOLKATA, MAHARASTRA, MADHYA PRADESH, MUMBAI, NORTH EAST, ORISSA, RAJASTHAN, WEST BENGAL, UTTAR PRADESH EAST, UTTAR PRADESH WEST, JAMMU & KASHMIR, PUNJAB, CHENNAI & TAMIL NADU who have successfully

3. Eligibility

This Competition is open for subscription for all Subscribers who fulfil the following criteria:

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of India;
- Subscriber must be a Competition Pack Member;
- Subscriber must belong to any one of the Circles mentioned herein;

- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to subscribing to the Competition, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein and the Terms and Conditions of the Competition Pack.

The Competition will be available in the below mentioned languages:

English, Hindi, Gujarati, Marathi, Punjabi, Bengali, Malayalam, Telugu, Kannada and Tamil.

A Competition Pack Member, by subscribing to the Competition Pack and/or participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or



regulatory requirement, business exigencies, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever.

Competition Pack Members who are roaming outside their home Circle will be barred from playing the Competition.

Further, the Competition Pack Members who participate in the Competition and are chosen as winners of each category of prizes in accordance with the winner selection process under the Terms and Conditions of the Competition ("Winner(s)") shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the players using such mobile number. If the Winner is not able to provide sufficient evidence to show that he/she is the owner of the mobile connection, the Organizer reserves the right to award the prize to the next eligible Winners or to forfeit the prize, at its sole discretion.

- **4.** These Terms and Conditions are available on the Website. The Terms and Conditions can be amended or varied from time to time or withdrawn without prior notice to You and therefore, please visit the Website to keep Yourself updated and informed.
- 5. Subscription Process to the Competition Pack
- a. The Subscribers have to call 5670330 (Toll Free) or Dial the Unstructured Supplementary Service Data ("USSD") string *567*899# or SMS ACT LAKH to 144 or 111 (Toll Free) or press 2 through Out Bound Dialers ("OBDs") or In Bound -dialers.
 - Subscription to the Competition Pack is completely free.
 - As soon as a Subscriber sends a subscription request:
 - Through USSD/SMS, he/she will receive an acknowledgement telling him/her that his/her subscription request has been received.
 - By pressing 2 through OBD/IVR, he/she will be informed that his/her subscription request has been received.
 - Once the Subscriber has been successfully subscribed he/she will get an SMS informing about the current or upcoming competition, prizes to be won and the current competition can be played at just Rs.5, Rs. 3 or Re 1 per day, depending on the balance available on his or her number registered with Vodafone India.
 - If the subscription is unsuccessful, the Subscriber will be sent an appropriate SMS on his/her number registered with Vodafone India telling him/her to try again later.
 - All Competition Pack Members will automatically be eligible to play and win prizes offered in all competitions launched as part of the Competition Pack, as will be detailed in the terms and conditions of that respective competition. These prizes may vary from one competition to the next.

Upon effective un-subscription, an SMS will be sent to the Vodafone India number of the Competition Pack Member confirming the un-subscription from the Competition Pack.
- All Competition Pack Members will be sent regular SMS updates and details about the
 current and the upcoming competitions, informing about the prizes and charges with the
 terms and conditions URL of the specific competition. The SMS will contain the method of
 unsubscribing from the Competition Pack, so that the Subscribers are educated about the
 same
- Competition Pack Members will not be charged any amount on non-competition days (after the end of one competition, and before the start of the next competition).

b. 6. Charging:

7. Competition on Voice

- Competition will be available on the toll-free number 5670330 for all Competition Pack Members.
- If a Competition Pack Member wishes to unsubscribe from the Competition Pack, that can also be
 done by calling the toll-free number 5670330 or by typing CAN LAKH as an SMS and sending it to
 144 or 111 toll-free. Upon effective un-subscription an SMS will be sent to the Vodafone India
 number of the Competition Pack Member confirming the un-subscription from the Competition Pack.
- All Competition Pack Members of the Competition Pack can play the Competition, by calling the toll-free number 5670330, after being charged for the day.
- Based on the amount charged, Competition Pack Members will be allowed to answer questions for that particular day.
 - Competition Pack Members who are charged Rs 5 will get to answer 7 questions.
 - o Competition Pack Members who are charged Rs 3 will get to answer 5 questions.
 - o Competition Pack Members who are charged Re 1 will get to answer 3 questions.
- After every question and answer, a "beep" prompt is played. Competition Pack Members can answer the question by pressing 1 or 2, only after the "beep" prompt.
- The questions under this Competition shall be based on general information available to the public at large.
- The Competition consists of a total of 420 questions, with 2 answer options each.
- All Competition Pack Members can play only up to 7 questions on a particular day. There will be a fresh set of 7 questions every day.



- Competition Pack Members can press * to listen to a question again.
- The Competition Pack Member can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.
- For every right answer the Competition Pack Member will get 1 point. There is no negative marking for a wrong answer.
- After every right or wrong answer, the Competition Pack Member will be played an appropriate prompt and given the next question. If a Competition Pack Member stops playing the Competition after answering the nth question then when he/she calls back on the toll-free number, as mentioned above on the same day, he/she will be played the (n+1)th question. If a Competition Pack Member stops playing the Competition without answering the nth question then when he/she calls back on the toll-free number on the same day, he/she will be played the nth question of the day. i.e., if a Competition Pack Member listens to the 4th question but drops the call without answering the 4th question, then when he/she calls back on the same day, he/she will be played the 4th question of the day, which may be different from what he/she received previously.
- Irrespective of whether or not the Competition Pack Member has answered all the questions on a particular day, when he/she calls on the next day, he/she will be played the first question of that day.
- The Competition Pack Member will be played the questions one after the other till he/she finishes answering all the questions for that day.
- There will be a black-out time for the Competition every day between 11:45 PM and 12:15 AM of the
 next day. This black-out time will be communicated to all Competition Pack Members at the time of
 subscription to the Competition Pack. During this time, the Competition Pack Members will not be
 allowed to play the Competition.

8. Selection of successful Winners – The selection process of the successful Winners for all the prizes in this Competition will be as follows:

Bumper Prize:- One MSISDN across all circle-groups as per the classification of circle groups* mentioned below, with the minimum cumulative score of 210 points, in the least amount of time during the Competition will be selected as the Winner of Toyota Etios Liva. The winning MSISDN will be removed from the list of eligible Competition Pack Members for the 2nd Prize.

2nd Prize:- One MSISDN per circle-group as per the classification of circle groups* mentioned below, with the minimum cumulative score of 175 points, in the least amount of time, during the Competition will be selected as the Winner of Gold Voucher worth up to Rs. 50,000.

Daily 1st Prize:- One MSISDN, per circle-group as per the classification of circle groups* mentioned below, with the score of 7 points, in the least amount of time, on a particular day, will be selected as



the Winner of mobile Recharge¹ worth up to Rs. 500. The winning MSISDNs will be removed from the list of eligible Competition Pack Members for Daily 2nd and 3rd prizes of that day.

Daily 2nd Prize:- One MSISDN, per circle-group as per the classification of circle groups* mentioned below, with the score of at least 5 points, in the least number of questions, in the least amount of time, on a particular day, will be selected as the Winner of mobile Recharge worth up to Rs. 208. The winning MSISDNs will be removed from the list of eligible Competition Pack Members for Daily 3rd prizes of that day.

Daily 3rd Prize:- One MSISDN per circle-group as per the classification of circle groups* mentioned below, with the score of at least 3 points, in the least number of questions, in the least amount of time, on a particular day, will be selected as the Winner of mobile Recharge worth up to Rs. 100.

¹ Recharge is the amount that will be given to the Winners as talk-time, based on the available denominations and/or offers in the respective circle-group or State. In case in any of the Circles or circle-groups, the talk-time recharge value or denomination offered in the Competition is not available, the Winners will be provided with the nearest value or denomination available for talk-time, / data or SMS recharge which could be equal to or closest to the recharge value or denomination offered. All taxes and charges including but not limited to State tax, cess, operator charges etc. on such recharge will be applicable and will be borne by the Winner.



- In the selection of the Bumper Prize or 2nd Prize, in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted for all the tied MSISDNs. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.
- In case of a tie in the selection of any of the Daily Prizes, all the tied MSISDNs will receive the prize.

- **9.** All prizes will be given after deducting various taxes, license fees and charges as applicable.

- **12.** All decisions of Organizer in respect of all transactions under this Competition, including without limitation the selection of Winners and other related transactions shall be final and binding and no correspondence or communication shall be entertained in this regard.
- **13.** All incidental costs/taxes/levies related to the prize(s), if any, shall be exclusively borne by the Winner, including but not limited to TDS, wealth tax (if any), insurance and any other taxes applicable by the Central, State or Municipal government.
- 14. After the selection and validation of the Winners of all the prizes under the Competition, the Winners will be contacted, by calling them on 3 consecutive days on the number of the Winner registered with Vodafone India, and will be given further details as to how, when and where they can collect their respective prizes. In the event the Winners do not answer the calls of the Organizer, an SMS will be sent to the MSISDN of the Winners intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective prizes ("Intimation"). The prizes must be claimed by the Winners within 30 days from the date of Intimation to the Winner, failing which, the prize(s) will be deemed to be forfeited by the Organizer(s) under the respective categories under the Competition. The Prizes offered under the Competition may be given to the Winners during a special event, the venue, date and time of which shall be announced by the Organizer, at its sole discretion, subsequent to completion of the Competition. In the event no special event is being conducted by the Organizer, the Winners shall



be requested to provide their address to which the prizes may be sent by Organizer, by calling the number provided in the SMS within 7 days from the date of sending the SMS, failing which the prize shall be forfeited. The prizes shall, under no circumstance be distributed from the amount charged by OnMobile or Vodafone India for playing the Competition. Delivery of prizes will be subject to the Winners giving the correct address and his/her availability there. The Winners agree that there shall be no liability on Organizer in the event such message does not reach such Winner on any account for any reason whatsoever. In the event that any of the Winners cannot be reached over phone or through SMS for a period of 3 days from the date of Intimation or are ineligible or are disqualified, for any reason whatsoever, the Organizer reserves the right to forfeit the prize at its sole discretion.

- 15. Without prejudice to the foregoing Clause 14, any failure on the part of the Winner under this Competition to comply with directions issued by the Organizer shall entitle the Organizer, at its discretion, to cancel and forfeit the prize for the said Winner and the same prize will be given to the next eligible Winner. The prizes shall be distributed only after and subject to confirmation of an existing Permanent Account Number ("PAN") of the Winner(s). All costs and expenses for collecting the prize unless otherwise specified shall be borne solely by the Winners under this Competition and the prize shall not be transferable and no request shall be entertained by the Organizer for such transfer. In the event the prizes cannot be delivered, when specified that they will be delivered, due to reasons beyond the control of the Organizer, the Winners shall collect them from the place specified by the Organizer.
- **16.** To be eligible to claim the prizes of the Competition, the winning MSISDNs have to be active Subscribers of Vodafone India at the time of the Winner announcement.
- 17. - **18.** By entering the Competition, You confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages including without limitation daily updates of the score of the Competition from the Organizer, as it may in its sole and absolute discretion decide.
- 19. Organizer, Vodafone India or their affiliates shall be entitled to use, in any manner, the details of the Competition Pack Members including the Information i.e. name, photograph, Vodafone India mobile number, address etc. for their sales, marketing and promotional purposes, including the prizes awarded to them, if any. By participating in the Competition, all participants hereby agree to the same. Organizer may, at its discretion, choose not to disclose the identity of the selected Competition Pack Member to other Competition Pack Members unless expressly mentioned herein.
- **20.** By participating in the Competition, Competition Pack Members consent to the following information relating to them to be exchanged between Vodafone India, OnMobile and their concerned vendors



- and/or published or otherwise communicated to in any media that the Organizer may deem fit, for the purpose of Winner announcement: name, mobile phone number, score and/or photograph.
- 21. Prize(s) shall not be transferable. Cash alternative for the prizes above may be given at the sole discretion of the Organizer. Mere participation in the Competition shall not entitle a Competition Pack Member to a prize. No other person or agent can claim the prize on behalf of the Winner.
- **22.** All prizes offered in this Competition are subject to availability. Organizer reserves the right to provide alternate models or brands of the same value, for any of the prizes or issue a Bank Voucher (defined below) for the value of the prize won under the Competition, after deducting applicable taxes, which may be redeemed by the Winner at stores accepting such Bank Voucher.
- 23. A Bank Voucher or Bank Card acts as a pre-filled card, in which the Winner's prize amount, less TDS if applicable, is available and is given to the Winners at the discretion of the Organizer. This Bank Voucher can be used or swiped as a debit card in all outlets where Bank Cards are accepted. The Bank Voucher or Bank Card is valid for a period of 2 years from the date of its issue. The applicable terms and conditions for such Bank Vouchers shall be the terms and conditions stipulated by the relevant Bank. This Bank Card or Bank Voucher may be issued by the Organizer, at its sole discretion, to any of the category of prizes.
- 24. The value of the vehicle offered as Bumper Prize in this Competition i.e. Toyota Etios Liva shall not exceed Rs. 5 Lakhs (ex-showroom price). In case the specified model, type of car offered in this Competition as Bumper Prize is discontinued or not available during or after the Competition, the Organizer will at its own discretion offer another vehicle of the same value which may or may not be of the same brand. If the Winner wants the exact same model or type of vehicle of the same brand mentioned as the Bumper Prize of this Competition i.e. Toyota Etios Liva and if the price of the vehicle increases during or after the Competition or at the time of prize distribution or Winner announcement period, the Organizer will only pay the value of the vehicle that was during the launch of the Competition and the Winner has to pay/bear the extra amount. The prize amount shall be given by way of cheque in the name of the dealer from whom the car is being purchased. The Gold Voucher will be given to the Winner(s) after deduction of such value equivalent to the amount of applicable taxes, including but not limited to, Tax Deducted at Source ("TDS") @ 30.99% or as applicable from time to time and applicable Value Added Tax on the purchase of the gold. The Winner will receive a TDS certificate in respect of the amount of tax deducted at source, and also a statement showing the value of the gold received.
- 25. The purity of the gold being offered as prize in this Competition will be of 22 carat certified gold.
