Duly completed application form should be submitted in the proforma appended, accompanied by a latest passport size photograph, attested copies of certificates in proof of age, educational qualification, mark sheets, experience, caste status(in case of SC/ST/OBC certificate issued by the Competent Authority in the prescribed form).
- 2. Name of the post applied for should invariably be mentioned on the top of the envelope and application should be addressed to the Director, ICAR Research Complex for Goa, Ela, Old Goa.
- 3. The prescribed qualifications are minimum and enhanced qualification do not entitle candidates to be called for written test/interview. Where the number of applications received in response to advertisement is large and it will not be convenient. Or possible for the Institute to call for test/interview to all candidates, the Director, ICAR Research Complex for Goa reserves the right to fix the criteria for calling the candidates.
