Probation Period – Selected candidate will be on probation for a period of 1 year. During the probation they will be paid monthly Salary equivalent to initial stage of pay-scale applicable to SMGS V.

Confirmation: The confirmation of **Chief Security Officer in Specialist Stream** will be subject to satisfactory completion of one year probation period.

In case of **Head of Defence service Cell**, the post will be on contractual basis for 03 years with half yearly reviews.

1. ELIGIBILITY CRITERIA:

a) Nationality / Citizenship:A candidate must be either (i) a Citizen of India or (ii) a subject of Nepal or (iii) a subject of Bhutan or (iv) a Tibetan Refugee who came over to India before 1st Jan. 1962 with the intention of permanently settling in India or (v) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India, provided that a candidate belonging to categories (ii), (iii), (iv) & (v) above shall be a person in whose favour a certificate of eligibility has been issued by the Govt. of India. A candidate in whose case a certificate of eligibility is necessary may be admitted to the examination/ interview but on final selection the offer of appointment may be given only after the necessary eligibility certificate has been issued to him / her by the Government of India.

He will also be responsible for making liasen and expanding relationship with different Offices and Headquarters of Army. He will be acting as one point contact for defence services for complaint redressal.

2. LOCATION:

The Office of the Chief Security Officer shall be located at Head Office, Kolkata and for Head of Defence Service Cell, the Bank may depute him anywhere in the country as per the bank's need.

3. SELECTION PROCEDURE:

Merely satisfying the eligibility norms does not entitle a candidate to be called for Interview. The Bank reserves the right to call only the requisite number of candidates for the Interview after preliminary screening / short-listing with reference to candidates qualifications, suitability, experience, etc.
