Applications are invited from eligible local candidates for filling up of 08 (eight) posts of Veterinary Officer /Jr. Disease Investigation Officer/Artificial Insemination Officer/Rinderpest Officer/Poultry Development Officer on temporary regular basis in PB-2 of ₹. 9300-34800 and Grade Pay of ₹. 5000/- under Sikkim State Animal Husbandry and Veterinary Services Department.

**A. ELIGIBILITY CRITERIA.**

1. *Minimum Educational Qualification* : *Bachelor of Veterinary Science and Animal Husbandry from a recognised University.*
2. *Other Qualifications* : (1) *Should be conversant with the customs and usages of Sikkim.*  
(2) *Should have valid Local Employment Card.*  
(3) *Should have communicative skill in English/ Hindi, Nepali and Mother tongue.*

(2) Degree Mark Sheet and Degree Certificate awarded by the University (3) Valid Local Employment Card issued by the competent authority of the Government of Sikkim, (4) Valid Certificate of Identification/Sikkim Subject Certificate and (5) Valid category certificate for BL/ST/MBC/OBC/SC certificate issued by the competent authority of the Government of Sikkim (6) No Objection Certificate from the Appointing Authority/ Head of Department in case of employed candidate (7) Registration Certificate with the State Veterinary Council/Veterinary Council of India.

No TA/DA shall be paid to the candidates for appearing the examination/Viva Voce etc.

**Admission at all the stages of examination for which candidates are admitted by the Commission viz: Main (written) Examination and Interview Test will be purely provisional and is subject to their satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission.**
