**Corrigendum to Employment Notification no. MESCOM/AGM(A)/AO(A)/ALM-
RECT/2011-12/13680 dated 09/12/2011.**

A) Applications are invited from qualified and eligible candidates for recruitment to the post of Assistant Lineman in the scale of ₹ 7950-150-8100-190-9050-240-10250-300-11750-360-16790 in Mangalore Electricity Supply Company Limited.

- Applications are invited from the “**Male/Female candidates**” who have passed 10th STD and three years pass certificate of “**Lineman/Electrician trade**” (ITC) imparted from the Industrial Training Institute of KEB/KPTCL.
- Applications are invited from “**Female Candidates**” possessing pass certificate of 18/24 months course as on 11.01.2012 (*being the last date fixed for submission of application for the notification dated 09.12.2011*) in “**Electrician/Electronics/Electronic Mechanic**” trade from Industrial Training Institutes (ITI) recognized by the Government of Karnataka.

Note: The male applicants who had earlier applied to the post of Assistant Lineman in Notification dated: 09/12/2011 need not apply once again and their applications submitted earlier will be considered.

1) Composition of Posts :

A) For the candidates possessing a pass certificate of 18/24 months course in “**Electrician/Electronics/Electronic Mechanic**” trade from Industrial Training Institutes (ITIs) recognized by the Government of Karnataka.

Note:

- i) GOK in its order no. EN 193 EEB 2012 dated 19-01-2013 has granted exemption from extending 30% reservation quota earmarked for women category in direct recruitment of Assistant Lineman.
- ii) GOK order vide no. EN 115 EEB 2010 (part-ii) dated 25-01-2012 has granted exemption from providing reservation to persons with disabilities as per section 32 of the Persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act 1995.
- iii) Candidates selected as Assistant Lineman will be posted anywhere within the jurisdiction of the MESCOM and posting to the existing vacancies.

2) Requisite Qualification:

A) For ITI candidates:

Should have a pass certificate of 18/24 months course in “**Electrician/Electronics/Electronic Mechanic**” trade from Industrial Training Institutes (ITIs) recognized by Government of Karnataka.

B) For ITC candidates:

Should have passed 10th Standard Examination and should have a pass certificate of THREE YEARS “**Lineman trade**”/“**Electrician trade**” (ITC) imparted by the Industrial Training Institutes of KEB/KPTCL.

Note: Candidates possessing qualification in other disciplines/branches other than what is specified above need not apply

Other Qualifications:

- i) Should have knowledge of Kannada in reading and writing.
- ii) Should have normal eye sight.
- iii) Should have satisfactory physical fitness and shall qualify in the Endurance Test.

3) Eligibility:

The candidates who have obtained minimum percentage of marks as prescribed below in the respective qualifying examinations only are eligible to apply for the posts.

4) Selection :

- i) **Recruitment to the posts of Assistant Lineman will be made by selection strictly on merit, based on the marks secured in the Qualifying Examination only.**
- ii) Eligible candidates will be called for Endurance Test in the ratio of 1:5.
- iii) Medical Examination will be conducted from the competent Medical officer during the endurance test and the candidate should have satisfactory physical fitness.

iv) Endurance test will be conducted in the following events;

- a) 100 meters Running : 14 seconds
- b) Skipping : 50 times in one minute
- c) Shot put 12 pounds : 8 meters throw (3opportunities)
- d) Climbing of Electric Pole : 8 meters height (compulsory)
- e) 800 meters running : 3 minutes.

v) No marks are allocated to the endurance test. However, in order to qualify for the selection, the candidate has to **compulsorily climb the electric pole (event No. d)** and get through in 2 events out of remaining 4 events (i.e. event No. a, b, c & e).

vi) The endurance test and verification of documents will be decentralized and will be conducted at the respective MESCOM's Circle Head Quarters. The details of MESCOM's Circle Head Quarters are as follows:

vii) Date, Time and Location of endurance test will be notified to the shortlisted candidates through website/news papers. Those candidates who give Mobile Number in their application forms will be intimated through SMS.

viii) The verification of the requisite certificates of the shortlisted candidates will be done at the time of the Endurance Test.

5) **Age:**

The candidates should have attained the age of 18 years as on the last date fixed for receipt of application and shall not be more than;

- i) 35 years in case of General Merit candidates.
- ii) 38 years in case of Category IIA, IIB, IIIA and IIIB candidates.
- iii) 40 years in case of SC/ ST and Category I candidates.

Note:

- a) The candidates who are trained for a period of THREE YEARS in “ Lineman/ Electrician” trade in KEB/ KPTCL Training Institutes, relaxation in the upper age limit will be given up to the period of training subject to a maximum of three years.
- b) Age relaxation from 09/12/2011 till the date of issue of Notification, will be extended to the female candidates possessing ITI Certificates as per the Orders of the Hon'ble High Court of Karnataka.
- c) Age relaxation from 09/12/2011 till the date of issue of Notification, will be extended to the candidates possessing 3 years ITC Certificates as per the Orders of the Hon'ble High Court of Karnataka.

- d) For Ex-Military Personnel (Ex-MP) the upper age limit is relaxable by three years in addition to the number of years of service rendered by them in the Armed forces of the Union of India not exceeding 45 years of age as on the last date prescribed for receiving the application.
- e) In case of in- service employees, the upper age limit is relaxable by the number of years of continuous service rendered by them, subject to a maximum of seven years.
- f) The candidates who worked or working on contract basis in the Corporation/Companies as Gangman/Bill boys/Professional Mazdoor/Temporary Cleaners/Sanitary worker and Temporary Meter Readers, the upper age limit is relaxable by number of years of service rendered by them subject to a maximum of 10 years. The candidate claiming age relaxation on the above basis has to produce certificate from the concerned KPTCL/ESCOMs authorities.
- g) As per the Order dated: 26.11.2013 of the Hon'ble High Court of Karnataka in Writ Appeal No: 3074-3083 of 2012, the age limit is relaxable from 12.12.2011 upto the date of this Notification, for the three years' ITC candidates who were eligible as on 12.12.2011.

6) **Application Fee:**

- 1) Rs. 400/- (Rupees Four Hundred only) in respect of candidates belonging to General Candidate and Category I, IIA, IIB, IIIA, IIIB.
- 2) Rs. 200/- (Rupees Two Hundred only) in respect of candidates belonging to SC/ST Category.

7) **Submission of Application:**

- a) Applications should be submitted strictly through "ONLINE" by logging on to MESCOM website at <http://www.mesco.in/>. Applications will not be accepted by any other mode.
- b) The website will be kept open for submitting "ONLINE" Applications from 15.03.2014 to 15.04.2014. The last date for submission of application is 17.00 hrs (5.00PM) of 15.04.2014.
- c) The candidates are allowed to apply only once and application once submitted cannot be altered under any circumstances.
- d) After applying, the candidates should obtain the Bank Challan generated on-line and pay the requisite application fee along with applicable bank charges in any of the branches of Corporation Bank.
- e) In case, the candidates fail to pay the fees after submitting the application, their applications will not be considered.

Special Note:

- Candidate who pays the requisite application fee, by obtaining 'Bank Challan', during the Banking hours between 15.03.2014 to 15.04.2014 after submitting the application through 'On-Line'; only such applications will be considered for recruitment.
 - The application fee paid before or after the NOTIFIED DATE, such candidate's application will not be considered for recruitment purpose and the amount paid will not be adjusted or refunded under any circumstances.
- f) Fees paid once shall not be refunded under any circumstances or adjusted towards future recruitments.

- g) After submitting the application ONLINE the candidates should obtain the printouts of acknowledgement and Bank Challan and same should be produced at the time of 'Endurance Test'.
- h) Candidates should submit the applications well in advance without waiting for the last date prescribed for submission.

8) **General Instructions:**

- a) No person who has been convicted of an offence involving moral turpitude or who has been temporarily debarred or disqualified by the Union or any State Public Service Commission from appearing for examination or selections conducted by it shall be appointed unless the Company after review of all the circumstances considers him suitable for such appointment.
- b) Candidates who obtain appointment by furnishing false information in the application are liable to be terminated.
- c) Postal address furnished in the application is final and no correspondence for change of address at a later date will be entertained.
- d) Candidates who have appeared for the qualifying examination but whose results are not declared before the last date fixed for receiving applications, need not apply.
- e) Before filling up the online application forms, the eligible candidates shall go through instructions made available in the website.
- f) Candidates are expected to know the criteria for claiming reservation under SC, ST, Categories I, IIA, IIB, IIIA, IIIB as well as norms for horizontal reservation under each quota prevailing in Government of Karnataka as on the last date prescribed for submission of application.
- g) The decision of MESCOM in matters relating to eligibility of candidates will be final and binding.
- h) Canvassing in any form for appointment will be a disqualification.
- i) Original documents/ Testimonials/ Certificates/ Records etc., shall be produced for verification with attested copy, only when called for.
- j) Only Indian citizens are eligible to apply.
- k) The Company reserves the right to cancel the Employment Notification during any stage and without prejudice to issue fresh notification, if necessary.
- l) No correspondence or enquiries will be entertained from candidates about the status of recruitment process.
- m) Candidates applied under Category – I, IIA, IIB, IIIA, IIIB, Scheduled Caste and Scheduled Tribe their appointment Orders will be issued only after receipt of validity certificate ['SINDHUTHVA PRAMANA PATRA'] from concerned competent authority irrespective of their selection[GM/ Category]
- n) All relevant information at various stages of recruitment will be made available on the MESCOM website <http://www.mesco.in/>.
- o) The selected candidates will have give an undertaking on a stamped paper of Rs. 200/- (Rupees Two hundred only) stating that he will serve the Company continuously for a minimum period of one year from the date of reporting.
- p) The applicants (**Female candidates**) possessing a pass certificate in ITI as on 11/01/2012 are only eligible to apply for the post.
- q) The candidates having both ITI and ITC qualifications, if desire to apply, they have to apply separately for ITI and ITC category.

9) Nature of Duties:

Excavation work for pole erection or cable trench, lifting of poles and fixtures, lifting or carrying medium weight line materials, Tools and Plant. Attend to patrolling of lines, service connection works, switch 'ON' and 'OFF' street lights, replacing street lamps, climbing pole/tower for line works and painting works, assisting Lineman/Line Mechanic/Wireman for line inspection and maintenance works of the lines, attend to fuse off calls and rectification of faults on lines on the direction of the concerned authority, attend to Telephone Board shift duties and cleaning of equipments. Assisting other staff in the performance of various duties relating to the works. Maintenance of diary and records of work while in-charge of camp duties. Such other work that the head of the office may assign in the interest of the Board. Also required to be worked in shift duties according to the nature of works assigned with respect to their postings.
