Note:

- The courses offered by Institutions/Universities through the regular mode should be approved/recognized by the necessary statutory bodies for employment to posts and services under the Central Government like Association of Indian Universities (AIU)/UGC/AICTE etc. Candidates who have obtained their qualification through the distance learning/part time mode are also eligible to apply provided that their qualification is recognised by the relevant statutory bodies for employment to posts and services under the Central Government. However, for the post of HR Executive the qualification of Post Graduate Diploma in PM/IR/Labour Welfare should be of minimum 2 years full time.
 - For all posts and across all categories i.e. Gen/OBC/SC/ST/PWD/ Departmental the minimum % of marks required in the qualifying degree is 60% except for the qualification of Post Graduate Degree for Security Officer, ICWA/CA for Finance and Accounts Officer, MBBS for Medical Officer, 'B' level diploma as defined by Deptt of Electronics, GOI for Programming Officer and Ministry of Transport's Certificate of competency of Master Foreign Going for Marine Officer where a 'Pass' in the qualifying degree is the **essential criteria**.
 - Calculation of percentage of marks in the qualifying degree is as per university/ institution rules.
 - Wherever CGPA/ OGP/ CPI/ DGPA or letter grade in degree is awarded, equivalent % of marks should be indicated in the online application **as per norms adopted by concerned University/ Institute. Please also obtain a certificate to this effect from the Univ./ Instt, which must be submitted at the time of interview.**
 - In case there is no mention of specialisation in the qualifying degree as required in the Minimum Essential Qualifications above, candidates must submit a certificate at the time of interview from their institution/ university with a clear mention of their specialisation in the qualifying degree.
 - Qualifications mentioned in the table above are sacrosanct. No equivalent qualifications shall be accepted e.g. for the post of Finance & Accounts Officer, qualifications such as Post Graduate Degree/ Diploma in Business Management with specialisation in Finance, which may be equivalent to an MBA with specialisation in Finance, shall not be acceptable. Similarly where the requirement is Graduate degree in engineering, AMIE which may be an equivalent qualification shall not be acceptable. In the same vein an Engineering Graduate in Information Technology shall not be eligible to apply for posts where a graduate degree in Computer Engineering is the essential qualification. The above examples are only illustrative in nature and it is reiterated that no equivalent qualifications shall be acceptable for any post.
 - Students in the final semester of the qualifying course of study may also apply provided their final results are declared on or before their scheduled date of interview (tentatively scheduled in the month of August 2014).
- 2: AGE LIMIT:** As on **11.04.2014** for all posts except Drilling and Cementing: **1.Gen.**-30 Years, **2. OBC (Non-Creamy Layer)** - 33 Years **3. SC/ST**- 35 Years and **4. PWD** - 40 Years for Gen, 43 years for OBC & 45 years for SC/ST category.

For Drilling and Cementing: As on **11.04.2014** **1. Gen.** - 28 Years, **2. OBC (Non Creamy Layer)** - 31 Years and **3. SC/ST** - 33 Years.

Note:

- Departmental candidates shall be given relaxation in age to the extent of their service rendered in ONGC.
- Age relaxation to Ex-Serviceman as per Govt. of India guidelines.
- CASTE CERTIFICATE:**
 - Candidate's seeking reservation as SC/ST/OBC, will have to submit at the time of interview, caste certificate, ONLY in the prescribed proforma meant for appointment to posts under the Government of India from the designated authority indicating clearly the candidates caste, the Act/Order under which the caste is recognised as SC/ST/OBC and the Village/Town the candidate is ordinarily a resident of.
 - Prescribed format of the caste certificate for SC/ST/OBC & PWD for employment in government undertaking is down-loadable from the online application site.
 - OBC candidates must ensure that they possess the latest Non Creamy layer certificate at the time of interview. They must also ensure that the name of their caste (including its spelling) as indicated in their certificates, should be exactly the same as published in the lists, notified by the Central Government from time to time. A certificate containing any variation in the caste name will not be accepted.
 - The OBC claim of a candidate will be determined in relation to the State (or part of the State) to which his/her father originally belongs. A candidate who has migrated from one State (or part of the State) to another should, therefore, produce an OBC certificate which should have been issued to him/her based on his/her father's OBC certificate from the State to which he (father) originally belongs.
 - No change in the community status already indicated by a candidate in his/her online application form for this examination will ordinarily be allowed.

B: SELECTION PROCESS

- (a)** Eligible candidates will be required to appear for **Written test** (Objective Type) comprising three sections-Concerned subject, General Awareness and an Aptitude test (comprising Reading Comprehension, Verbal/Non-verbal Reasoning, Numerical Ability/Quantitative Aptitude, Data Interpretation etc) for a total duration of **Three hours**. **(b)** The section on the concerned subject shall consist of 80 questions, the General Awareness section shall consist of 40 questions and the Aptitude test section shall consist of 30 questions. All questions shall be of one mark each. There shall be no negative marking. The total marks allotted to the written test is **150**. **(c)** The syllabus of test paper shall be as per UPSC standard of I.E.S. for Engineering subjects, Civil Services for Management disciplines and M.Sc. level for others. **(d)** The candidate shall be tested on his knowledge of the subjects in the essential qualification (declared in his online application) e.g. a candidate who has a qualification of B.Tech. (Mechanical) and who may otherwise be eligible for either of the posts of AEE(Drilling), AEE(Cementing), AEE(Production), AEE(Mechanical), Transport Officer and Materials Management Officer shall be tested in the paper of Mechanical Engineering only. **(e)** The language of the test shall be English. However the candidates can opt for a paper in Hindi as the language of the test. **(f)** The written test is tentatively scheduled on **22.06.2014**. *(The exact date of the test will be available on ONGC's website www.ongcindia.com).* **(g)** The candidates who qualify in the written test shall be called for psychometric test and interview as per the criteria decided by the Management. **(h)** In order to qualify in the interview, General and OBC candidates must obtain a minimum of **60%** marks and SC/ST & PWD candidates must obtain a minimum of **40%** marks **(i)** The final merit list shall be prepared based on the weightages assigned to various parameters as per following:

- Written test - 60 marks
 - Interview - 15 marks
 - Qualification - 25 marks
- Total 100 marks**

- (j) In order to be selected, candidates, in addition to fulfilling the requisite qualification criteria, **are required to qualify in the written test and thereafter again in the interview separately.**
 (k) Departmental candidates shall be given first consideration in matters of selection viz-a-viz other candidates.

C: WRITTEN TEST CENTERS

The written test will be conducted at the following cities:

Candidates have to choose one of these cities as Test Centre and **no change will be allowed** subsequently except during the period of editing the online application. However, ONGC **reserves the right to change** any of the above mentioned test cities at its discretion.

D: HOW TO APPLY

Eligible applicants would be required to apply Online **ONLY** (on the Internet) through the link 'Apply Online' on ONGC's website: www.ongcindia.com. **No other mode, repeat no other mode of application shall be accepted.**

- Candidates can apply for a maximum of two posts in order of preference. As an exception, those candidate who apply for the post of AEE (Drilling)/AEE (Cementing) as their first preference are eligible to apply for two more posts as a second and third preference.
- For posts where no vacancies are earmarked for Reserved category, the candidate can apply as a General candidates. However they may indicate their actual category in the online application so as to avail of fee concession as mentioned at point 8 below.
- Before registering/submitting their applications on the website the candidate should possess the following:
 - Valid E-mail ID.
 - Challan form downloaded and duly filled with the fee deposited and acknowledged by the concerned bank.**
 - Scanned copies of recent passport size colour photograph of the candidate with white background (not more than **50 KB size**) and signature of the candidate (not more than **20 KB size**).
 - The candidate can access the online application form at www.ongcindia.com. The online registration site would be **open from 1000 hours on 22.03.2014 to 1800 hours on 11.04.2014.**
 - No changes shall be allowed once the candidate has saved and submitted his application. No subsequent changes will be allowed in the application form after this period.

Payment is to be made as per the designated process only. **Registration fee by any other mode of payment would not be acceptable.** Applicants should not deposit fee through instruments like Demand Draft/ Banker Cheques/PO, online transfer of money into ONGC account etc. If any applicant makes payment through any such mode fee **will NOT be returned/refunded**. Applicants should therefore pay the fee through downloaded challan form (designated process) only.
