- Period from and period to in the excel sheet should be equal to the period earlier selected by the dealer.
- STN/Invoice date should be within period from and period to.
- No. of F-forms generated cannot be greater than the no. of forms mentioned in the CST return by the dealer.
- Value of the field '**Inter-State "Arrivals" otherwise than by way of sale from other States' (8(A))** in Monthly return JVAT 200 should be equal to the summation of the value entered in the column 'Value of Goods' of excel (Requisition of Form F).
- Value of the field '**Detail of Inter-State arrivals by way of Stock Transfer from Outside the State**' under column 27 in the CST Return Form, should be equal to the sum of the three months (of the quarter) of the field '**Inter-State "Arrivals" otherwise than by way of sale from other States' (8(A))** in Monthly return JVAT 200

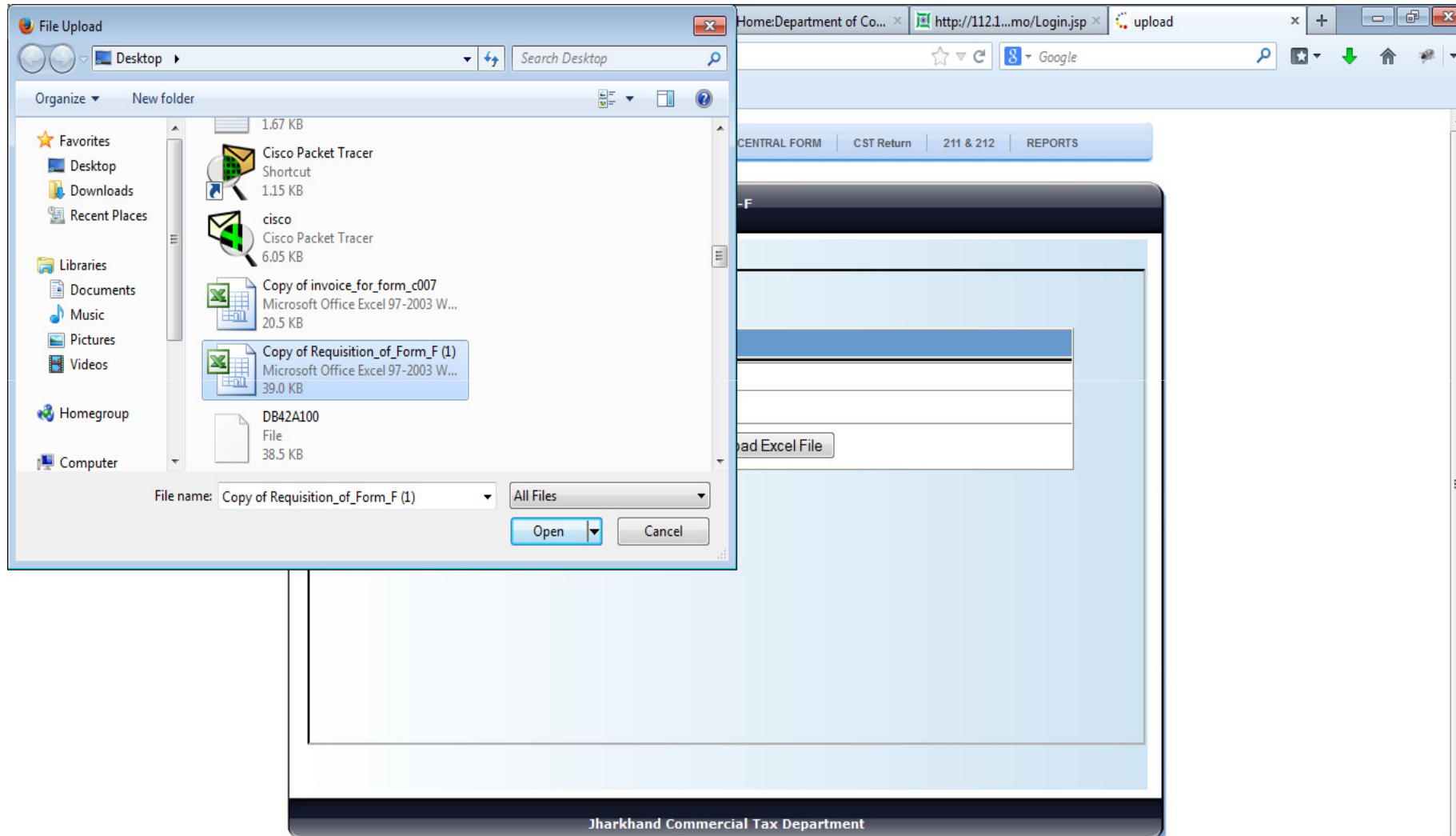
