# **TERMS AND CONDITIONS – WIN 2 LAKHS GOLD COMPETITION**

"Win 2 Lakhs Gold Competition" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India ("OnMobile" or "Organizer") and is open for participation for active¹ pre-paid and post-paid category of Subscribers² (hereinafter referred to as "Subscriber(s)") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter referred to as "Vodafone India") during the period from 31st March 2014, 00:00:01 hrs to 29th May 2014, 23:59:59 hrs (hereinafter referred to as the "Competition Period"). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit, and any such change shall be published on the website, http://vodafone.contestzone.in and www.vodafone.in ("Website").
- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles ("Circle(s)") of ANDHRA PRADESH, ASSAM, NORTH EAST, BIHAR, DELHI, GUJARAT, HARYANA, KARNATAKA, KERALA, MAHARASTRA, MADHYA PRADESH, ORISSA, MUMBAI, PUNJAB, HIMACHAL PRADESH, JAMMU & KASHMIR, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, KOLKATA, WEST BENGAL, CHENNAI and TAMIL NADU.

<sup>1</sup> An active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module ("**SIM**") on a regular basis for purposes other than to participate in competitions under this Competition or any other competitions offered by the Organizer and Vodafone India, jointly.

<sup>&</sup>lt;sup>2</sup> Subscriber shall mean the rightful user of the Vodafone India connection, pre-paid or post-paid, in whose name the mobile phone connection number (MSISDN) is registered with the operator. - Warrant that You have read understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to playing this Competition, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

The Competition will be available in the below mentioned languages:

English, Hindi, Gujarati, Marathi, Punjabi, Bengali, Malayalam, Telugu, Kannada and Tamil.

A Participant, by participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever. Participants who are roaming outside their home Circle will be barred from playing the Competition.

## 6. Competition on Voice

- Participants will be informed of the rules, prizes to be won, Terms and Conditions URL of the Competition, on calling the number 5670330 or 567035 or 56703 to play the Competition.
- Participants may send PRI, RUL, TNC or SCORE as an SMS to 5670330, without additional charges for such SMS's to know about the details of the prizes applicable under this Competition,

- applicable rules and Terms and Condition URL and current Level (defined below) score and total score of the Participant in all the Levels respectively.
- All questions under this Competition shall be based on information available to the public at large.
- The Competition consists of questions with 2 answer options each.
- All Participants may choose to play all questions at once, else he/she can continue playing on any of the days during the Competition Period.
- Level 1 will consist of 50 questions, Level 2 will consist of 150 questions and Level 3 will consist of 900 questions which may be played by the Participants. After each answer, the Participants will be informed of their updated scores, followed by the next question and answer options.

In case in any of the Circles or Circle-Groups, the talk-time recharge value or denomination offered in the Competition is not available, the Winners will be provided with the nearest value or denomination available for talk-time, data or SMS recharge which could be equal to or closest to the recharge value or denomination offered. All taxes and charges including but not limited to State tax, cess, operator charges etc. on such recharge will be applicable and will be borne by the Winner.

#### Level 2 prizes-

- In case of a tie in the selection of the Level 1 – Daily Prize, for Tamil Nadu and Chennai Circle, the Winner will be the MSISDN which has achieved the target score of 5 points first in time.

- In case of a tie in the selection of the Level 1 Daily Prize, for all other Circle-Groups, the Winner will be selected through a system generated process.
- In case of a tie in the selection in any of the other prizes, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. - 21.
