

# RECRUITMENT OF MERITORIOUS SPORTSPERSON IN CENTRAL EXCISE & CUTOMS DEPARTMENT, PUNE

The Chief Commissioner of Central Excise, Customs & Service Tax Pune Zone, invites applications for the recruitment of Meritorious Sportsperson in different Games / Sports as listed below for the posts of Tax Assistants (T.A.) in the Pay Scale of Rs. 5200-20200 (PB3) + Grade Pay of Rs. 2400. The posts are purely on temporary basis but likely to be made permanent. The Probation period is of two years.

#### **ELIGIBILITY CONDITIONS**

- 1. AGE LIMIT: For the post of Tax Assistant the Age limit will be between 20 and 27 years as on 5<sup>th</sup> May, 2014 (the closing date of receipt of application) (relaxable upto 5 years for General / OBC candidate and 10 years in case of SC/ST candidates). The age limits also relaxable upto 40 years in case of SC/ST Departmental candidate.)

**07. SELECTION OF THE CANDIDATES:- The** applications will be scrutinized and suitable candidates will be short listed for further selection procedure. For selection, the short listed candidates are required to appear for following tests:-

#### Ground (Physical) / Proficiency Test Written Test & Interview.

Success in the above testes confers no right to appointment unless Department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post. At the time of Physical Test / Ground Test the candidate has to produce the Certificate from the Respective Sports recognized Associations in the proforma enclosed herewith.

- **08.** Selected candidates will be required to give an undertaking not to apply for intercharge transfer for minimum period of 10 years.
- **09.** Only attested copies of the documents in support of claim regarding Date of Birth, Educational Qualification, Sports Eligibility Certificates, Caste Certificate etc. should invariably be accompanied with the application.
- 10. The candidate on appointment will be liable for posting at any place in Pune Cadre Controlling Region i.e. any formation of Pune, Mumbai, Nasik Aurangabad, Kolhapur, Commissionerates. The declaration to this effect to work at any place should be submitted alongwith the application.
- 11. The Candidate after appointment has to pass the Departmental Computer Proficiency Test of 8000 Key depressions per hour within a period of two years i.e. before completion of his / her probation failing which the probation period will increase.
- 12. Application for each post should be sent separately.

Incomplete and unsigned applications will be rejected and no correspondence in the matter will be made with the applicant. Eligible candidates will be called for above said testes and interview.
