- D. <u>SELECTION PROCEDURE</u>: Selection will be through Screening (Written) test, Trade test, Computer Operation Application test, Interview and Medical Examination by OIL Board.

Those who qualify in the written test will be called for shorthand and computer typing test and those who qualify in shorthand and typing test will be called for computer operation skill test. Lastly those who qualify in computer operation skill test will be called for viva-voce.
- ii) Candidates already employed in Government, PSUs, Autonomous Bodies must apply through proper channel or produce "No Objection Certificate" at the time of interview.
- The applicant should be registered in the Employment Exchange and must quote Employment Exchange Registration Number in the application.
- iv) Final selection will be subject to Verification of Certificates, Pre-employment Medical Examination, Police Verification Report of Character & Antecedents and after compliance with all other formalities as per the rules of the Company.
