

## **CLARIFICATION**

In pursuance of the judgment of the Hon'ble Supreme Court of India, in the case of P.A. Inamdar v/s State of Maharashtra & others 2005 (6) SCC 537, Unaided Private Medical and Dental Colleges have a right to admit students and to hold common entrance test, Therefore at this stage admissions to all the seats in the Unaided Private Homoeopathic Medical Colleges will be done as per **Asso-PGH-CET-2014** merit only.

As per the aforesaid judgment there is NRI Quota up to 15% at the discretion of the member colleges particulars regarding the same will be displayed on the official website of **AMHMCM. (www.amhmcm.org)** 

The programme mentioned in this brochure is applicable to the Postgraduate admissions to be given for the academic year 2014-15 at the Unaided Private Homoeopathic Medical Colleges.

However, it is made amply clear that after publication of the brochure, if there is any order by appropriate authority or any legislation or judgment by any court of law, then the **AMHMCM** will abide by the appropriate order/ enactment/ judgment, reserving its right to challenge and without prejudice to rights as per the TMA Pai Foundation (2002) 8 SCC 481 P. A. Inamdar's case (supra.) judgments.

The permission to conduct ASSO-PGH-CET-2014 & admission to Post-Graduate courses in Homoeopathy of all private Homoeopathy Medical Colleges of Maharashtra for academic year 2014-15 is given by Pravesh Niyantran Samiti of state of Maharashtra.

#### Association Post Graduate Homoeopathy – Common Entrance Test – 2014

#### 1. **INTRODUCTION:**

The entrance examination for the Post Graduate Courses in Homoeopathy in the State of Maharashtra for the Academic year 2014-15 shall be conducted by the Competent Authority appointed by the Association of Management of Homoeopathic Medical Colleges of Maharashtra (AMHMCM). The entrance examination shall be conducted for all the seats in the private unaided Homoeopathic Colleges.

#### 2. COMPETENT AUTHORITY:

Dr. D.G.Bagal, Mumbai is appointed by the Association as the Competent Authority and will be available at Association's office as and when required. The Competent Authority will supervise the conduct of ASSO-PGH-CET-2014 and also supervise evaluation of answers and declaration of results & merit list. The Competent Authority will issue necessary executive instruction for implementation of these rules and provide relevant information to be published and communicated. The management of Association will be fully responsible for evaluation of answer sheets, declaration of results and merit list and conduct of examination.

#### 3. NUMBER OF SEATS:

The list of postgraduate courses available is given in **Annexure - A** and the number of seats in the respective Colleges is given in **Annexure - F** 

#### 4. ELIGIBILITY CRITERIA:

#### M.D. (Homoeopathy) Courses:

- 4.1 A candidate who has passed final B.H.M.S. Examination or equivalent qualification in Homoeopathy included in the second schedule to the Act after completing 1 year compulsory rotating internship.
- 4.2 Bachelor of Homoeopathic Medicine and surgery or equivalent qualification in Homoeopathy included in the second schedule to the Act after undergoing a course of study of not less than 2 years duration (Graded B.H.M.S. degree)
- 4.3 A candidate who has completed one year compulsory internship or is likely to complete the same on or before **31/05/2014** can appear for Asso-PGH-CET-2014.

# CENTRAL COUNCIL OF HOMOEOPATHY (PUBLISHED IN THE GAZETTE OF INDIA: EXTRAORDINARY DATED 16TH NOVEMBER, 1989)

# (AMENDMENTS PUBLISHED IN GAZETTE OF INDIA: EXTRAORDINARY, ON 22ND FEBRUARY, 1993, 5TH NOVEMBER 2001, 2ND MARCH, 2012).

Admission to Course.

- (1) No candidate shall be admitted to M.D. (Hom.) course unless the possesses the degree of:-
- Bachelor of Homoeopathic Medicine and Surgery or equivalent qualification in Homoeopathy included in the Second Schedule to the Act, after undergoing a course of study of not less than five year and six months duration including one year compulsory internship; or
- (ii) Bachelor of Homoeopathic Medicine and Surgery (Graded Degree) or equivalent qualification in Homoeopathy include in the Second Schedule to the Act, after undergoing a course of study of not less than two years' duration. (2)The University or the authority prescribed by the Central Government or the State Government, as the case may be, shall select candidates on merit for Post Graduate Course. Preference shall be given to candidates who have worked in rural areas for two years in respects of one seat in each subject as per merit.

#### 5. NON ELIGIBLITY OF CANDIDATES:

Following candidates are not eligible for applying to Asso-PGH-CET-2014 :-

- 5.1 Candidates who are not completing internship on or before **31/05/2014**.
- 5.2 Candidates who are registered for PG Degree and have not completed the terms.

# Note: The candidates should read all instructions of eligibility and he/she will be fully responsible for fulfillment of all the conditions of eligibility. The Competent Authority will not be responsible for screening of the candidates.

#### 6. APPLICATION PROCEDURE

- 6.1 Prescribed application forms can be obtained from the Notified Centers (Annexure- B) against DD drawn on the Nationalized Bank in favor of AMHMCM payable at Mumbai of Rs. 700/- (Rs. Seven Hundred Only) between 10 am to 4:30 pm.
- 6.2 Application forms will also be available from Association's office by post with an additional DD of Rs. 200/- for postal charges.
- 6.3 The Application Form must be filled by the candidate in his/her own handwriting using black ballpoint pen. The application form complete in all respect shall be submitted directly to the office of AMHMCM, Mumbai either in person or by Post or Courier. The filled Application is to be duly returned along with DD in favor of AMHMCM payable at Mumbai for Rs.3,000/-(Rs. Three Thousand only.)
- 6.4 Application Form should be submitted by Post and must be accompanied by a self-Addressed and stamped envelope along with Receipt-cum-Identity Card (Annexure- C) for acknowledgement.
- 6.5 Incomplete application forms will be rejected.
- 6.6 The official at the AMHMCM office/notified centers office while accepting the application form shall issue the Receipt-cum-Identity Card attesting the photograph of the candidate with signature and stamp.

- 6.7 Candidate should download the Admit Card from website www.amhmcm.org by 8/04/2014. In case the candidate does not receive Admit Card by **10/04/2014** he/she should approach the Association Office for further instructions. admit card will be available on our Website : www.amhmcm.org
- 6.8 The candidate is required to preserve the Receipt-Cum-Identity Card and Admit Card for all future reference & correspondence.
- 6.9 The candidate shall submit one and only one application form. In case candidate submits more than one application form, he/she shall be disqualified for appearing for Asso- PGH-CET-2014.
- 6.10 The copy of admit card which is available on Website : www.amhmcm.org
- 6.11 The Association will not be responsible for Postal delays.
- 6.12 Roll Nos. and admit card will be displayed on the website by 8/04/2014.

#### 7. CONDUCT OF Asso-PGH-CET-2014

- 7.1 All the eligible candidates are required to take the Asso-PGH-CET-2014 at their own cost.
- 7.2 The Asso-PGH-CET-2014 will be conducted on **13/04/2014** between 2 pm-5 pm.
- 7.3 The Asso-PGH-CET-2014 will be conducted in Mumbai city only.
- 7.4 The examination will be conducted in English language.
- 7.5 Asso-PGH-CET-2014 paper will be of three hours duration containing 250 Multiple Choice Questions (MCQ). Questions will be of single best response objective type With four answer options. Each correct response shall be awarded one mark. There shall be no negative marking for wrong answers. Scratching, overwriting, tick mark, multiple answers will be considered as wrong answers and no marks are awarded to them.
- 7.6 The Common Entrance Test shall be of the standard of B.H.M.S. Examination and shall cover all the subjects of B.H.M.S. The tentative number of questions of each subject will be as given below:

#### 8. **RESULT**:

- 8.1 The Competent Authority shall conduct Asso-PGH-CET-2014, get the answer- sheets evaluated and prepare the Merit list.
- 8.2 The Competent Authority, Asso-PGH-CET-2014, will prepare a Merit list indicating Merit number, Name, Marks scored by the candidate.
- 8.3 The Merit list will be available on AMHMCM website only on **17/04/2014**.
- 8.4 The statement of marks of the candidate indicating marks obtained and merit number of the candidate will be dispatched by Post.
- 8.5 The candidate who wants duplicate mark sheet will have to apply to the Competent Authority with fees of Rs.1,000/- (Rupees One Thousand Only) paid by D.D. drawn in favor of AMHMCM payable at Mumbai.
- 8.6 There will be no rechecking/revaluation of the answer sheets. However the candidate can apply for verification of marks to the Competent Authority Asso-PGH-CET-2014 within 5 days of declaration of result in prescribed form (Annexure- D) along with prescribed fees of Rs. 1,000/- (Rupees One Thousand Only) to be paid by Demand Draft in favor of "AMHMCM" payable at Mumbai.

#### 9 MERIT LIST

9.1 To be eligible for selection to 85% of the seats in PG Homoeopathy Courses a candidate will be selected from merit of Asso- PGH-CET-2014 as per direction as...

"admissions to students drawn otherwise than the source of only one CET does not satisfy the mandate contemplated by Hon'ble Supreme Court of India in (2003) 6 Supreme Court cases 697 Islamic Academy of Education v. State of Karnataka Para No. 16 as re-produced hereunder:

"We thus hold that the management could select students, of their quota, either on the basis of the common entrance test conducted by the State or on the basis of a common entrance test to be conducted by an association of all colleges of a particular type in that State e.g. medical, engineering or technical etc. The common entrance test, held by the association, must be for admission to all colleges of that type in the State. The option of choosing, between either of these tests, must be exercised before issuing of prospectus and after intimation to the concerned authority and the Committee set up hereafter.

If any professional college chooses not to admit from the common entrance test conducted by the association then that college must necessarily admit from the common entrance test conducted by the State, After holding the common entrance test and declaration of results the merit 1st will immediately be placed on the notice-board of all colleges which have chosen to admit as per this test. A copy of the merit 1st will also be forthwith sent to the concerned authority and the Committee. **Selection of students & must then be strictly on the basis of merit as per that merit List'!**"

9.2 15% of the seats (NRI) will be filled in by the management from candidates fulfilling the norms as laid down by the Pravesh Niyantran Samiti Govt. of Maharashtra.

- 9.3 TIE-BREAKER: In case of two or more candidates obtaining equal marks in the Asso-PGH-CET-2014 the inter-se merit of such candidates will be determined in the order of preference as under:
- 9.3.1 The Candidate with more aggregate marks (converted into percentage) at First, Second, Third & Fourth B.H.M.S. Examination taken together shall be preferred. If the tie still persists.
- 9.3.2 The candidate with more aggregate marks (converted into percentage) at Final B.H.M.S.Examination will be preferred. If the tie still persists.
- 9.3.3 The candidate with more aggregate marks (converted into percentage) at Third B.H.M.S. Examination will be preferred if the tie still persists.
- 9.3.4 The candidate with more aggregate marks (converted into percentage) at Second B.H.M.S. Examination will be preferred
- 9.3.5 If the tie persists, the older candidate will be preferred.
- 9.4 The original statement of marks of the candidate indicating Merit Number, Name, Marks Scored, will be dispatched on the address filled in the application form by the candidate & it will be also available on our Website: www.amhmcm.org
- 9.5 In case of any typographical error in mark sheet e.g. Name, Age, Sex Category, etc., representation should be submitted within two days from the date of declaration of result to the Competent Authority, AMHMCM, Mumbai.

#### 10. **RESERVATION**

- 10.1 Reservation of seats for SC, ST, VJ, NTB, NTC, NT-D and Other backward class including special backward class (Group-A, Group-B, Group-C, Group-D), will be as per Government notification No MED-2006/1196/CR /204/06 EDU-1 (2) dated 24/06/2006 subject to legislation of Parliament or Judicial Pronouncement.
- 10.2 Candidates belonging to Backward Class Category will be required to submit the Caste certificate and Caste/Tribe validity certificate and non-creamy layer Certificate from the appropriate authorities of the Govt. of Maharashtra.

#### **11. SELECTION PROCESS**

- 11.1 The selection to a Course/College will be made as per Merit-Cum- Preference given by the candidate.
- 11.2 The Candidate desires of claiming constitutional reservation must claim the Same in the preference form. A Candidate belonging to backward class must specify the name of the reserved category and must produced all the relevant documents. The Competent Authority will reserve seats for constitutional reservation if applicable, **out of state reserve candidate will be treated as a open category as per the announcement of Government Ordinance** whenever admissible.

The selection process shall be as follows:

- 11.3 The Preference form shall be given to the candidates immediately after the Asso-PGH-CET-2014 is over at the examination centre itself.
- 11.4 Eligible candidates from Asso-PGH-CET-2014 Merit List will be required to fill in the "Preference Form". The preference form should be submitted directly to the office of the AMHMCM on or before **03/05/14**. Preference form received after **03/05/14** will not be considered. The Preference filled by the candidates will be centrally processed and the final merit list prepared. As per the Merit-cum- Preference the selection to be made and the list of selected candidate will be declared on the website. As per the declared Selection List the candidates should report to the allotted college and join in the specified period. along with all the relevant original documents and fees of the college declared by the Shikshan Shulk Samiti.
- 11.5 The list of subjects and college codes is provided in Annexure-E.
- 11.6 Subject and College Codes:
- a. The subject and college code is a four digit number specific for each subject and College combination.
- b. Subject and College code numbers are specific & fixed.

c. Code number represents a particular subject is a specific College. e.g.

- d. Subject & College Codes are given to course existing in those colleges. For these codes one and more number of seats may be available. Therefore subject and college code choices can be given as preferences.
- e. Seat distribution Chart (Annexure- F): Contains distributions of available seats. The college wise & subject wise distribution will be made available on the website of AMHMCM. Seat distribution chart is subject to change as per instructions of University/ Availability/ Non availability of PG Teachers etc.

#### **11.7 PREFERENCE FORM :**

Candidate will collect the Preference Form after the examination is over on **13/04/14** and fill in the relevant information along with his/her Roll Number, Merit Number, Asso-PGH- CET-2014 Marks and sent it to the AMHMCM. Preference Form should be handled carefully. Please do not fold, staple and spoil in any way as Preference Forms are to be scanned. Last date for submission of Preference form is **3/05/14**.

- 11.8 Candidate will be issued only one Preference Form. Another Preference Form will not be issued to the candidate on any grounds.
- 11.9 In case the candidate is not eligible for admission according to the rules the Preference Form issued, already will be treated as cancelled.
- 11.10 Candidate should read all instructions before filling the Preference Form. Candidate should note carefully the subject and college code. The candidates are instructed to make 2 Photo copies of the Preference Form, 1 Photo copy may be used as specimen copy to fill in the same for practice. Once the candidate is satisfied with his/her filled in choices in the specimen copy, he/she may fill on the Preference Form provided by AMHMCM by using Black Ball Point Pen. Second photo-copy will be retained by the candidate as his/her office copy for record.
- 11.11 Candidate should write subject of Preference and college code numbers in the boxes. One digit in each box (4 digits in 4 boxes). Candidate should write the codes with Black Ball Point Pen with neat legible and clear handwriting. Please do not fold, pin, the preference form as the form will be scanned by the computer.
- 11.12 Candidate can fill minimum 1 preference or any desired number or maximum preferences available. The same subject and college code should not be filled more than once. In case the candidate fills the same code more than once, higher Preference will be considered and subsequent repeated Preference Number will be ignored. If the candidate fills any wrong code of subject and college, it will be rejected
- 11.13 If a candidate does not give Preference for a particular subject and college then it means that he / she is not interested in those subjects and college combinations. Candidates should note that there will be No Change / Addition / Deletion in the Preference at a later stage.
- 11.14 The Candidate selected as per his / her Merit cum Preference for a particular subject in the particular college, then he / she has to join the course as per procedure. In failure to join the allotted course within the stipulated time, he/she is debarred from subsequent admission process of Asso-PGH-CET-2014.
- 11.15 In case the candidate is not selected in the first round, then he/she remains eligible for the subsequent round for the preferences which he/she has given in the Preference Form.
- 11.16 For filling of vacant seats after first round same Preference Form will be considered and no separate Preference Form will be required to be filled in by the candidate.
- 11.17 Candidate should submit only one Preference Form, Submission of more than one Preference Form will lead to disqualification.
- 11.18 Candidate should note that the Preference of subject and college combination codes once entered in the data shall be final and irrevocable. Thereafter, there can not be any change, addition or deletion of Preference entered by candidate. This final data shall be used in entire selection process for the admission to Postgraduate Courses.

#### **12 SELECTION PROCEDURE:**

- 12.1 The collected data will be centrally processed for the selection of candidates for P.G. Homoeopathy Courses.
- 12.2 The selection will be done as per Merit and Preference given by candidates in Preference Form.
- 12.3 The list of candidates selected for P.G. Homoeopathy Courses shall be displayed on the AMHMCM website www.amhmcm.org.
- 12.4 The first selected list will be declared on **06/05/14** on the website of AMHMCM and the list of selected candidates will be sent to all concerned colleges. Candidates should report and pay the fees and submit all the original certificates with one set of attested Photo copies of all the certificates, at the respective Colleges by **12/05/14**. No separate selection letter will be issued to the selected candidates.
- 12.5 If the Candidate does not report within this date, his/her selection stands cancelled and will be debarred from the subsequent process.

#### 12.6 Filling Vacant Seats :

12.6.1 After selection in first round if the candidate desires to retain the same selection (Subject & College) and does not want to take any further betterment then he/she can do so by filling 'Status Retention Form' in prescribed Performa (Annexure-G). Status Retention F or m is to be submitted to the Competent Authority through the college, where he/she is admitted. However, candidate should note that he/she will be deleted from the further selection process for the academic year 2014-15.

- 12.6.2 After the first round, the vacant seats, if any, will be filled in the second round of selection on 16/05/14. For these seats the selected as well as the not selected candidate who have filled in the Preference Form are eligible except those who have opted for status retention.
- 12.6.3 The candidate selected in the first round except the candidates who have submitted the status retention form as per procedure will be considered for betterment (higher preference exercised) in the subsequent round. The shift in such betterment shall be compulsory and mandatory. Such candidates will have to collect the original certificates and admissible refund of fees as per procedure mentioned in Asso-PGH-CET-2014 Brochure and join the New Course and college before **24/05/14**.
- 12.6.4 Candidate who has confirmed his / her admission may cancel it by submitting an application to the concerned Principal.

#### 12.7 The Procedure for refund of fees shall be as follows.

12.7.1 Refund of fees by the College after change of College/course for higher preference by the Competent Authority for the same year, the deduction of Rs 2000/- from the tuition fees up to **24/05/14** After **24/05/14** the cancellation will be no refund.

12.7.2 Candidate who has confirmed his/her admission with filling up status retention wishes to cancel the admission for any other reason except betterment the refund of fees will be as follows

Up to **16/05/14** Permissible deduction 30% of the remitted fee. Up to **24/05/14**, Permissible deduction 50% of the remitted fee. After **24/05/14**, no refund.

- 12.7.3 Candidate cancel his/her admission (Except rule 12.8) after cut off date (31/05/2014) will have to pay the fee of whole course to the college.
- 12.8 If a candidate expires or becomes invalid within three months from the date of admission, full refund shall be made after deducting Rs 1000/- as administrative charges.
- 12.9 Any seat remaining vacant after the second round of admission will be filled in by the specific college, inviting applications from eligible candidates and appeared for Asso-PGH-CET-2014.
- 12.10 Last date (cutoff date )of admission process of filling vacant seats for Postgraduate Courses is **31/05/14.**
- 12.11 The candidates must produce original certificates at the time of admission to the college and a set of attested photocopy of each of the document as per the list given below. The candidate should bring the following documents as per their admission as a Regular candidate:
  - Nationality Certificate or valid passport
  - Statement of 1, 2, 3 & Final B.H.M.S. or Gr. B.H.M.S.
  - exams. Passing/Degree Certificate.
  - Attempt Certificate for all the years.
  - Internship Completion Certificate
  - Registration Certificate of Maharashtra or other Council of Homoeopathy or receipt of applied for registration.
  - Migration certificate if require.
  - College leaving Certificate/T.C.
  - Education gap certificate after completing Internship
  - Physical fitness Certificate
  - Statements of Marks of Asso-PGH-CET-2014
  - Caste Certificate and Caste validity certificate where applicable.
  - Non-creamy layer certificate where applicable
  - Gazette copy of change of name.
- 12.12 The registration once granted is valid only if the teacher and the Dean are satisfied about regularity, diligent persuasion of studies by the student as well as good conduct.
- 12.13 Candidate selected for admission shall be subject to disciplinary rules of University / Institution / Government and Management.
- 12.14 A candidate selected for Postgraduate Degree will not be allowed for change of subject.
- 12.15 In case of dispute in the matter of allotment of seat/ course / Institution or any other matter pertaining to the provisional selection or cancellation of admission, the decision of the management of the concerned institution shall be final and binding.

- 12.16 A candidate will have to deposit all his/her relevant original certificates, documents along with the complete tuition fees to the concerned college.
- 12.17 Cutt of date for admission to P.G. courses in Homoeopathy for Maharashtra is **31/05/2014**.

#### 13. **DISCIPLINE**:

- 13.1 Any candidate / authorized representative or accompanying person is Found obstructing the admission process, trying to influence in unlawful Manner /creating nuisance, the candidate shall be liable for disqualification from the process of selection. The decision taken by the Management in this respect shall be final and binding.
- 13.2 All candidates selected shall be subject to the disciplinary rules of the Institution, University, Government and Management.

#### 14. **LEGAL JURISDICTION:**

All disputes pertaining to the conduct of examination and selection process shall fall within the jurisdiction of Mumbai High Court bench at Mumbai only or of the legal jurisdiction of the institution concerned.
