3.	Besides the appointment of faculty on regular basis, the advt. also includes invitation of proposal for appointment on long term (up to 10 years as per attached letter of MHRD) on deputation basis and <u>re-employment of superannuated teacher on contract basis</u>. Those especially eminent scholars serving or retired who fulfill the requirements of specialization of a subject may also apply.
