Applications are invited by the Commission for the below mentioned posts under Government of Goa. For details of posts, Departments, Scale of pay, age and educational qualifications and experience kindly refer to Commission website <http://goapsc.gov.in>. Candidates may download the application form along with the instruction to the candidates from the same website to apply for the post separately. The last date for receipt of applications in the Commission is 15.05.2014.

2. Candidates shall note that the Application Fee is enhanced to ` 400/- for General Category Candidates and those for SC, ST, OBC, Physically Handicapped and Ex-serviceman, it is 50% of the Application Fee i.e. ` 200/-. The application form should be accompanied by an Indian Postal Order or Demand Draft for the amount equivalent to the application fee payable to "The Secretary, GOA PUBLIC SERVICE COMMISSION" payable at Panjim.

3. Incomplete applications in any manner are liable to be rejected summarily by the Commission.

4. "The upper age limit shown against each post is relaxable upto 5 years for the candidates belonging to SC/ST, upto 3 years for candidates belonging to OBC, upto 5 years (total 10 years for SC/ST & 8 years for OBC in respect of posts reserved for them) to blind, deaf-mute and orthopedically handicapped person and upto 5 years for CFF. Age is also relaxable for Government Servants upto 5 years as per the instructions issued by the Government from time to time".

5. In case of non-availability of suitable candidates with the knowledge of Konkani, for the posts in professional colleges, Consultants in Directorate of Health Services and highly technical/scientific posts, this requirement can be relaxed.

6. Prescribed EQs are minimum & mere possession of same does not entitle the candidates to be called for interview. Where number of applications received is large, the Commission will short list the candidates to be called for interview as mentioned in the "Instructions".

Educational & Other Qualifications:-

Essential: (i) A recognised medical qualification included in the First or the Second Schedule or Part II of the Third Schedule (other than Licentiate qualifications) to the Indian Medical Council Act, 1956 (Act No. 102 of 1956). Holders of qualifications included in Part II of the Third Schedule should also fulfil the conditions stipulated in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (Act No. 102 of 1956). (ii) Post graduate degree or equivalent in the concerned super-speciality or equivalent. (iii) At least ten years teaching and/or research experience in a recognized Medical College/Teaching Institution in the subject of super-speciality after obtaining the qualifying degree of Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.). (iv) Knowledge of Konkani.

Desirable: Knowledge of Marathi.

NOTE: For candidate with Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.) degree of three years duration, experience required is at least nine years after qualifying degree.

Educational & Other Qualifications:-

Essential: (i) A recognised medical qualification included in the First or the Second Schedule or Part II of the Third Schedule (other than Licentiate qualifications) to the Indian Medical Council Act, 1956 (Act No. 102 of 1956). Holders of qualifications included in Part II of the Third Schedule should also fulfil the conditions stipulated in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (Act No. 102 of 1956). (ii) Post graduate degree or equivalent in the concerned super-speciality or equivalent. (iii) At least four years teaching/research experience in a recognized Medical College/Teaching Institution after obtaining the qualifying degree of Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.). (iv) Knowledge of Konkani.

Desirable: Knowledge of Marathi.

NOTE: For candidate with Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.) degree of three years duration, experience required is at least three years after qualifying degree.

3. Assistant Professor in Paediatric Surgery 1 post

Educational & Other Qualifications:-

Essential: (i) A recognised medical qualification included in the First or the Second Schedule or Part II of the Third Schedule (other than Licentiate qualifications) to the Indian Medical Council Act, 1956 (Act No. 102 of 1956). Holders of qualifications included in Part II of the Third Schedule should also fulfil the conditions stipulated in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (Act No. 102 of 1956). (ii) Post graduate degree or equivalent in the concerned super-speciality or equivalent. (iii) At least one year teaching and/or research experience in a recognized Medical College/Teaching Institution in the subject of super-speciality after obtaining the qualifying degree of Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.). (iv) Knowledge of Konkani.

Desirable: Knowledge of Marathi.

NOTE: For candidate with Doctorate of Medicine (D.M.)/Master of Chirurgiae (M.Ch.) degree of three years duration, no experience is required.

Holders of qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in Section 13 (3) of the Indian Medical Council Act, 1956. (ii) Post Graduate degree qualification in the speciality concerned or equivalent. (iii) At least 3 years teaching experience in the concerned speciality as Senior Resident/Registrar/ Tutor/Demonstrator in a Medical College/Teaching Institution. (iv) Knowledge of Konkani. **Desirable:** Knowledge of Marathi

Essential: (i) A recognised Medical qualification included in the First or Second Schedule or Part II of the Third Schedule (other than Licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of Section 13 of the Indian Medical Council Act, 1956. (ii) Knowledge of Konkani.

Desirable: (i) Registered for post graduate Degree in concerned speciality. (ii) Knowledge of Marathi.

(ii) Postgraduate degree, failing which post-graduate diploma, in the speciality concerned. (ii) Post Graduate Degree in speciality concerned. (iii) 3 years work in a responsible position concerned with their speciality after post-graduation Degree. (iv) Knowledge of Konkani.

Holders of educational qualifications included in Part II of the Third Schedule should fulfill the conditions stipulated in Section 13 (3) of the Indian Medical Council Act, 1956 or degree of Goa Medical School (Medico Cirurgiao). (ii) Completion of compulsory rotatory internship. (iii) At least 3 years experience in the Administration of Medical Care. (iv) Knowledge of Konkani.

Provided, however, that candidates, who are or have been awarded Ph.D. degree in compliance of the "University Grants Commission (minimum standards and procedure for award of Ph.D. Degree), Regulation 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Colleges". Age: Not exceeding 42 years.

Educational & Other Qualifications:-

Essential: (i) Master's Degree in Library Science/Information science/ documentation or an equivalent professional degree with at least 55% of marks or its equivalent grade of 'B' in the UGC seven point scale plus a consistently good academic record, computerization of library. (ii) Qualifying in the National Level Test (NET) conducted for the purpose by the UGC or State Level Test (SET) accredited by the UGC. Those holding Ph.D Degree are exempted from NET. Candidates holding Ph.D. degree and are already in the University system and have obtained Master's Degree prior to 1991 be given relaxation of 5% from 55% to 50% of marks for appointment to the post of College Librarian. (iii) Knowledge of Konkani.

Desirable: (i) M.Phil./Ph.D. Degree in Library Science/Information Science/ Documentation / Archives and Manuscript Keeping. (ii) Knowledge of Marathi.

(ii) B.E./B.Tech. and M.E./M.Tech. in relevant branch from a recognized University with First Class or equivalent either in B.E./B.Tech. or M.E./M.Tech. (iii) Minimum 10 years experience in teaching/research/industry out of which at least 5 years shall be at the level of Associate Professor Or (iii) Minimum 13 years experience in teaching and/or research and/or industry. (iv) Knowledge of Konkani.

Note: In case of research experience, good academic record and books/research paper publications/IPR/patents record shall be required as deemed fit by the expert members of the Selection Committee.
