<u>MEANS CRITERION</u>: The Gross Annual Income of a student's parents/ guardian and his family from all sources in the preceding financial year of 2013-14 (from 1<sup>st</sup> April 2013 to 31stMarch, 2014) <u>must not exceed</u> Rs.4,50,000/-(Rupees Four Lakhs Fifty thousand only) \*

\*While computing the Gross Annual Income of the family, the Income from all sources of both parents and income in student's name, if any, will also be taken into consideration for applying the Means Criterion for all the classes. In case of the parents who are in service( salaried class), the Gross Annual Income of the parent as shown in their IT Form16 for the corresponding financial year will be taken in to account to determine the Annual Income.

#### FREE STUDENTSHIP

ELIGIBILITY: Those students who satisfy the specified "Means Criterion" as stated above, but do not satisfy "Merit Criterion", may be granted exemption from payment of Tuition Fee, subject to approval on merit of each case by the competent authority subject to clearing all prescribed credit requirement during the session 2013-14 and having no backlog subject(s)including EAA.
