- (vi) The Grand Prize trip for all Disney Parks & Disney Cruise Line may not be sold, traded, transferred, rescheduled or refunded nor redeemable for cash.
- C. TWDCI shall provide the Grand Prize trip to the Grand Prize Winner and his/her family members only if the Grand Prize Winner and his/her family members hold a valid passport with a minimum of 6 months validity from the trip date and any other document(s) as required by the VISA authorities of the respective trip destinations..
