"Ride the Mahindra Thar or Jeeto Shaandar Mahindra Thar Competition" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100-India("OnMobile" or "Organizer") and is open for participation for active¹ pre-paid and post-paid category of Subscribers² ("Subscriber(s)") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter referred to as "Vodafone India") as part of the Vodafone Competition Pack (hereinafter referred to as "Competition Pack") during the period from 1st June 2014, 00:00:01 hrs till 30th July2014, 23:59:59 hrs (hereinafter referred to as the "Competition Period"). - In the selection of the Bumper Prize or 1st Prize or Monthly Prize or Weekly Prize, in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted for all the tied MSISDNs on voice.
