# **Prospectus for Admission to Professional Degree Courses 2014 in Post Basic BSc Nursing under SI-MET**

## **1. Introduction**

1.1 State Institute of Medical Education and Technology (SI-MET) was established in May-2008 by the Government of Kerala with a view to promote Medical Education and Research in the State and to run Institutions in medical education and research. The control, administration and management of the affairs of the Institutes shall vest in the Governing Body constituted by the Government with the Hon: Minister for Health, Government of Kerala, as Chairman, Secretary to Government, Health & Family Welfare, Government of Kerala as Vice Chairman and 12 senior officials of Government of Kerala as members.

1.2 SI-MET has established 3 Nursing Colleges in the state during 2009-10 in Malampuzha (Palakkad Dist.), Uduma (Kasaragod Dist.) and Palluruthy (Ernakulam Dist.) with an annual intake of 60 seats each. SI-MET have also established 2 Post Basic B Sc Nursing Colleges during 2010-11 at Thripunithura (Ernakulam Dist.) and Mundur (Palakkad Dist.) with an annual intake of 30 seats. SIMET has started one more Nursing College in 2011-12 in Mangattuparamba (Kannur Dist.) for Post Basic B.Sc. Nursing course with an annual intake of 40 seats.

### **1.3 Vision :**

The main vision of the Institute is to generate, transfer and propagate knowledge in Medical, Nursing and Paramedical fields in the three systems of Modern Medicine, Ayurveda and Homoeopathy, Allied Sciences, Medical Technology, Medical Administration and Management.

### **1.4 Mission**

1. To establish modern educational institutes in the State of Kerala, with a view to promote teaching, research and development in the field of medical education, medical science, technology and their interfaces.
2. To train and acquaint the professionals in the medical, nursing and paramedical and medical management and technology of the country with the latest developments in these fields
3. To collaborate with national and international institutions engaged in the research and developmental activities and specialising in the subjects of interest to the institute and seek recognition from Universities/ Governments other speciality bodies and organization for the courses offered by it.
4. To establish and run hospitals, laboratories, sub-centres etc. as required for the furtherance of the objectives of the Institute.
5. To conduct lectures, seminars, and courses and organize symposia, conferences, workshops, in-service training etc. in the fields related to medical education, medical sciences, technology and their interfaces.
6. To enable inclusive approach for the educational development of SC/ST and OEC students in Medical, Nursing and Paramedical areas, throughout the State.

- a. **General Merit seats:** The seats under General Merit will be filled purely on merit basis irrespective of the category/ community to which the candidates belong.

Admission process of allotment to Government Merit seats (50 %) under SI-MET Colleges of Nursing will be done by the Director, LBS Centre for Science and Technology under the supervision of the Director of Medical Education, as per the G.O (MS) No.148/2014/H&FWD dated 22/05/2014. Candidates are requested to visit the official website of LBS centre [www.lbskerala.com](http://www.lbskerala.com), [www.lbscentre.org](http://www.lbscentre.org)

- b. **Management seats:** are the Seats, other than Government General Merit seats (40%), against which the SI-MET will make allotment. There will not be any type of reservation in the Management seats. Candidate shall pay the Tuition fees fixed by the Government and special fees fixed by the Governing Body of SIMET.
- c. **NRI seats :** NRI seats (10%) are those seats set apart for the son/ daughter, brother/ sister, niece/ nephew/ first cousin or dependant of Non Resident Indian citizen or in their absence, foreign citizen of Kerala origin or in their absence NRI's who are non-Keralites, which will be allotted by the SI-MET. There will not be any type of reservation in the NRI seats. Candidate shall pay the Tuition fees fixed by the Government and special fees fixed by the Governing Body of SI-MET.

NRI candidates seeking admission to Post Basic BSc Nursing Course should enclose a copy of one of the following documents to prove the NRI status of his/ her parent and declaration of the NRI in the prescribed form to establish his/ her relationship with the candidate.

- NRI certificate : Any one of the following certificates :-
    - a. NRI Account number. Certificate issued by the Scheduled bank stating that he/ she is Non Resident Indian holding a NRI account other than a zero balance account
    - b. Attested copy of the employment certificate and relevant pages of the certificates
    - c. Certificate from the Embassy concerned
  - Sponsorship certificate in the attached format.
  - Attested copy of the relevant pages of the passport containing Visa details
  - Undertakings stipulated in the prospectus
- d. If candidates are not available under NRI quota, the vacant seats will be filled up under Management quota by SIMET.

3. **DURATION OF THE COURSE :** 2 years

#### 4. **ELIGIBILITY FOR ADMISSION**

##### 4.1 **Academic Eligibility:**

- a. Candidate should have passed +2/Equivalent examination with Physics, Chemistry and Biology as optional subjects. They should have also passed the qualifying examination ie General Nursing and Midwifery Course, from an institution recognized by the Indian Nursing Council and concerned State Councils with minimum of 50% marks in aggregate. No rounding off of the percentage of marks to the nearest whole number is permitted.
- b. Candidates as per Clause 4.1.a. shall have obtained registration with the Kerala Nurses and Mid-wives Council and copy of the registration certificate is to be submitted at the time of submission of application. Candidates who have studied outside Kerala shall have to submit copy of the registration certificate of the concerned nursing council of the state from where they have qualified, along with their application and shall have to produce their registration certificate in original obtained from Kerala State Nursing Council at the time of admission.

##### 4.2 **Age**

The upper age limit for candidate shall be 48 years as on the last date for submission of application.

- 4.3 Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE certificate showing date of Birth/Copy of the birth certificate from appropriate authority should be furnished along with the application as proof of age.

#### 5. **HOW TO APPLY**

**Merit seats are filled up by LBS list. There will be separate application forms** for (i) Management seats (40%) and (ii) NRI quota seats (10%). The candidates applying for Management quota /NRI quota should apply to SI-MET, in the prescribed application form issued by the SI-MET. Separate application fee should be remitted for the application forms, for Management quota seats and for NRI seats. If there is vacant NRI seats the same will be allocated to Management quota .

- a. *Issue of application form and prospectus* : The application forms and Prospectus can be obtained from the following offices of SI-MET on all working hours on payment of Rs. 500/- directly or by post by sending DD for Rs.550/-, drawn in favour of the “Director, SI-MET” payable at Thiruvananthapuram.

- e. Incomplete/belated applications will be rejected. The office will not be responsible for the postal delay or any mishaps. Candidates are therefore advised to apply sufficiently early.

## 6. SELECTION

- a. Selection of the candidates will be done based on the merit
- b. Candidates should bring all the documents in original for verification at the time of counselling.
- c. Admission to management seats will be conducted on the basis of marks obtained in the qualifying examination or after conducting entrance examination subject to the decision of the Government in the matter.

## 7. ADMISSION

- a. Admission will be subject to the general information and rules stipulated as per the prospectus for admission to Post Basic BSc Nursing Degree course 2014-15 Government merit seats G.O (MS) No. 148/2014/H&FWD dated.22/05/2014 and further amendments/ orders issued by Government / Governing Body of SI-MET regarding the admission.
- b. Selected candidates will be informed of the date and time of interview and admission, in due course, through website of SI-MET. **Candidates are requested to visit the Official Website of SI-MET ([www.simet.in](http://www.simet.in)) regularly for notifications and announcements.**
- c. The selected candidates shall pay the fees for the first year of the course at the time of admission which will not be refunded.
- d. Selected candidates for admission under Management /NRI quota, are requested to remit fees in the prescribed chalan form in lump sum in the SI-MET Directorate Current Account No. 67130144345 of SBT, Pettah Branch, Trivandrum. The fee amount includes Tuition fee, Special fee, Caution Deposit and any other fees. Candidates are requested to remit the fees in any of the branches of the State Bank of Travancore in Kerala. Chalan forms can be downloaded from the website [www.simet.in](http://www.simet.in). Duplicate copy of chalan duly attested by the remittance branch of SBT should be submitted to the Principal of the College for admission. However, a photocopy of the same may be retained by the candidates for future reference. Candidates are also advised to produce the filled up chalan form to the College for verification of the correctness of entry prior to the remittance of money into the bank.
- e. The fee will be as fixed by the Government /Governing Body of SIMET
- f. All the selected students should get themselves vaccinated against Hepatitis B before admission. Certificates to the effect should be produced at the time of admission or before commencement of the course.
- g. Physical Fitness Certificate in the relevant format given in Annexure D of the Prospectus
- h. **The Candidates admitted against Management seats and merit seats in Self Financing colleges under Govt., control, on discontinuance of course in the first year/ request TC for joining other courses/colleges or other purposes, after the cut off date to be fixed by the Govt or the closing date of admission whichever is earlier, are liable to pay liquidated damages equal to 2 times the annual tuition fee paid by them for the first year, irrespective of annual family income/nativity/reservation status..**



- i. **Levying amount towards liquidated damage from candidates discontinuing their studies after the first academic year:**
- (i) **Candidates admitted against Government seats in Govt. /Self Financing Colleges or in Management seats in Govt controlled Self Financing Colleges, who discontinue the course after the first academic year, are liable to pay liquidated damages equal to the total amount of tuition fee payable for the remaining year(s) of study.**
  - (ii) The candidates can be transferred from one SI-MET College to another SI-MET College, as per the proceedings of the Director, SI-MET . No transfer will be permitted after the cut off date specified by the apex body.

**j. The cut off date of closing of admission in respect SI-MET will be four weeks before the closing date of admission decided by the Government first for the operation of clause stated in para 7 (h), (i) (1) above. Further extension of time for admission, if any, will not be applicable for the operation of clause stated in para 7 (h), (i) (1) above.**

## **8. OTHER INSTRUCTIONS**

### **8.1 Preventive measures against ragging:-**

According to the Kerala Prohibition of ragging Act, 1998, ‘ragging’ means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to that student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a students to do any act or to perform something which such student will not in the ordinary course be willing to do. All institutions will have to abide by the directives of the Honourable Supreme Court of India, Dated May 16, 2007 in SLP No. (S) 24295 of 2006 University of Kerala Vs Council, Principal’s Colleges, Kerala & Ors [with SLP (C) No. 24296-99/2004 & W.P (Crl) No. 173/2006 & SLP (C) No. 14356/2005] and the recommendations approved by the Honourable Supreme Court of India on effective prevention of ragging in educational institutions. In case, the applicant for admission is found to have indulges in ragging in the past or if it is noticed later that he / she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution. It shall be the collective responsibility of the authority of the institution to see to it that effective steps for preventing ragging are taken. Anti- ragging committees and anti ragging squads will have to be formed to take effective measures against ragging and they should adhere to the stipulations and effectively monitor and comply with the directives. Each of the students of the institution and his/her parents, or guardian are required to submit a combined undertaking at the time of registration/admission in prescribed format available in Annexure-C which is mandatory for registration/admission.

**8.2 Use of mobile phone:**

Uses of Mobile phone by the candidates are not allowed in the campus. Any violation of the prohibition will lead to stringent disciplinary action by the college management.

**8.3** All the students who are selected should obey the rules and regulations of the institution without fail.

**8.4** They should come to the college properly and neatly dressed in accordance of the college dress code and have to wear prescribed uniform with ID card while they are on duty in the clinics

**9 SYLLABUS**

SI-MET Colleges of Nursing, Thripunithura (Ernakulam Dist), Mundur (Palakkad Dist) and Kannur are affiliated to Kerala University of Health Sciences, (KUHS) Thrissur and are following the syllabus stipulated by this University and Indian Nursing Council

**10 RECOGNITION/ APPROVAL**

SI-MET Colleges of Nursing in Thripunithura (Ernakulam Dist), Mundur (Palakkad) and SI-MET Colleges of Nursing, Kannur are recognised / approved by Indian Nursing Council, New Delhi, Kerala University of Health Science (KUHS) and Kerala Nurses and Midwives council (KNMC)

**11. SYSTEM OF EXAMINATION**

Examinations (University and internal) are conducted as prescribed by Kerala University of Health Science (KUHS)

**12 FEE STRUCTURE**

Will be as in the previous year

Fee pattern will be as follows :

*Hostel fee, Caution Deposit etc. will be fixed as decided by SI-MET. Admission to College Hostel will be according to the availability. PTA fund Rs.1000/-.*

**13. ALLOTMENT PROCESS**

13.1 Candidate who fails to appear for the counselling as per schedule will forfeit his /her chance for admission . However, if a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorized person can act as a proxy at the risk of the candidate on production of authorization letter in the form **given in Annexure - A**. Authorization letter once received will be considered as valid for the entire allotment process, unless the candidate revokes it in writing. A photocopy of the filled up authorization letter should also be brought by the proxy at the time of first appearance. The original authorization letter will be retained and the photocopy will be returned to the proxy with acknowledgement. This photocopy with the acknowledgement on it must be used for subsequent appearance(s) if any.

13.2 The additional seats, if any, sanctioned during the validity of the rank list shall be filled up from the same rank list.

#### **14. DATE OF JOINING :**

It is mandatory for the candidate to join the course on the date intimated by the Director of SIMET, Thiruvananthapuram, if selected at the time of counselling.

14.1 **Joining time :** No extension of joining time shall be granted by the Director of SIMET, Thiruvananthapuram to the allotted candidates under any circumstances.

#### **15. Commencement of the Course, Attendance, Duration of leave etc.**

15.1 The duration of the Post Basic BSc. Nursing course including University Examination is two years. For the purpose of reckoning the duration of the course, any candidate will be deemed to have joined the course on the date on which the candidate actually commences the academic programme as certified by the Principal concerned. He/she will have to complete the total duration of the course before being given the course certificate.

15.2 The candidate should earn 80% attendance for each year of the course separately for appearing for the examination.

#### **16. LIQUIDATED DAMAGES & EXECUTION OF BOND**

##### **16.1 General Terms :**

The candidate selected for Post Basic B.Sc Nursing Degree course shall have to execute bond in Kerala Stamp paper worth Rs.100/- at the time of joining the course to the effect that

a) He / she shall not discontinue the Course, allotted to after the validity period of the Rank List.

##### **16.2 Conditions :**

- a) There shall be a bond for all the candidates as per clause 16. A copy of the bond attached as **Annexure as B**
- b) A student who discontinues the course after the validity period of the select list mentioned in clause 16.1 (a) above, he/she shall pay Liquidated Damages is equal to the total amount of the annual tuition fee to be paid for the 2 years .Those who are not remitted the 1<sup>st</sup> year fee should pay an amount equal to the 2 year's tuition fee. Those who are remitted the 1<sup>st</sup> year fee shall pay the 2<sup>nd</sup> years tuition fee
- c) No Admission shall be valid with out getting the bond as detailed above executed at the time of joining or within a period of 7 days at the discretion of the Principal concerned. Format of Bond will be available in the office of the Principal of the Nursing College concerned.
