Applications are to be submitted on line from 09.06.2014 to 28.06.2014, 5 P.M through Calicut University website "www.universityofcalicut.info"

1. Signed print out of application bearing Passport size Photograph attested by the Gazetted Officer along with (i) the original chalan receipt for having remitted the fee of Rs.300/- (Rs.100/- for SC/ST candidates on the basis of valid community certificate issued by the

competent authority) to Calicut University Funds at Calicut University Fee Counter/Calicut University Janasevanakendra/Akshaya Centres/through SBT e-payment/online Banking (SBT) (ii) attested copies of certificates as proof of qualifications, age and community should be forwarded to the Chief Co Ordinator, CCSIT Centre, Calicut University Campus, University of Calicut, P.O calicut University-673635. so as to reach on or before 5 P.M on 30.06.2014.

- 2. The online Registration I.D.No. should be written by the candidate on reverse side of the chalan receipt/DD as the case may be. This I.D.No should also be mentioned by the candidate in all future communications.
- 3. Those who are awaiting the results of the qualifying examination can also apply. They have to submit the copies of Marklist to Chief Co Ordinator, CCSIT Centre, Calicut University Campus, University of Calicut, P.O, Calicut University within 6 days of the publication of Calicut University/Government Examination Results in order to finalise the Rank list with in the stipulated time.
- 4. The Chief Co-Ordinator, CCSIT Centre, Calicut University Campus is authorized to conduct Entrance Examination and admission as per rules and allot students to the Centres. The Chief Co-ordinator will forward a copy of the Rank list as well as the list of students allotted to various centres to the Directorate of Admission, Tagore Niketan, University of Calicut. Norms and Regulations relating to Master of Computer Applications - MCA

- 1. Final year regular Bachelor's Degree students are also permitted to appear for the Entrance Examination subject to the condition that the entire mark lists of all parts of the qualifying examination shall be produced by the candidate at the time of allotment.
- 2. Reservation to SC/ST/OBC/OEC/BPL and all other eligibilities will be made as per rules.

Quota for Physically Handicapped.

3% of the total seats available are reserved for candidates with physical disabilities. 'Person with disability' means a person suffering from not less than 40% of any disability as certified by a medical authority. Generally, candidates who have a minimum of 40% disability alone will be eligible to apply for this quota. A disability certificate from the District Medical Board obtained within 12 months from the date of submission of application and a certificate obtained from a Medical Officer not below the rank of Assistant Surgeon to the effect that the candidate is fit enough to undergo the M.C.A. Course are to be produced at the time of counselling.

Quota for OBC

Candidates claiming OBC reservation should produce both Income Certificate and Community Certificate obtained from the Village Officer / Tehsildar at the time of counselling. Only non- creamy layer candidates will be considered for this quota.

Quota for SC/ST

For claiming reservation under SC/ST quota, candidates should produce the Community Certificate issued by the Tehsildar in original at the time of counselling. Lakshadweep candidates should produce Nativity Certificate issued by Lakshadweep administration.

The seats not availed under this category will go to non creamy layer OEC candidates.

Quota for BPL Forward Class

BPL candidates who belong to communities, which do not have any communal reservation, are eligible for this quota. Community Certificate from Revenue authorities and BPL certificate from the Local Self Government Institution should be produced at the time of counselling for availing the reservation under this category.

Transfer.

The transfer from one Centre to another on higher option after the counselling will be made strictly on the basis of the rank secured by the candidate in the entrance examination.

Entrance Examination

The examination will be of 2 hours duration and will have 100 objective type questions of 1 mark each from the disciplines as noted below.

- Date of publication of rank list-12th August 2014 (Tuesday)
- Dates of Counselling-19th and 20th August 2014 (Tuesday and Wednesday)
- Commencement of 1st Semester Classes-1st September 2014.(Monday)
- Centres of examination- Kozhikode and Thrissur

(Time and venue of the examination will be announced later)

Applicants can download their hall ticket from the website www.universityofcalicut.info using their online registration number.

Applicants should invariably bring the hall ticket while appearing for the examination.

The Question Booklet issued to candidates should be returned along with the Answer Sheet to the Invigilator on completion of the Examination.

Rank list and Counselling.

Rank list will be prepared on the basis of total marks secured by the candidates in the entrance examination and will be published in the University website www.universityofcalicut.info along with schedule for counselling. Centralized counselling for admission will be held in Calicut University Campus. No intimation will be sent to individuals for the counselling/admission. Candidates are advised to visit the University website frequently or to go through the University press release in the leading dailies. Allotment of seats on each category will be purely based on the rank secured by the candidates. The candidates, who secure a higher rank, will be given priority to select the Centre of their preference.

The candidates should bring the following documents while appearing for centralized counselling.

- 1. Hall ticket of the Entrance Examination
- 2. SSLC or any equivalent school certificate to prove date of birth.
- 3. Transfer and Conduct Certificate.

- 4. Original Mark lists of all parts, Provisional Degree / Degree Certificate and Equivalency Certificate (in the case of candidates from Universities outside Kerala) of the Qualifying Exam with photocopies of the same.
- 5. Income Certificate/Community Certificate/Non-Creamy layer Certificate/Nativity Certificate/Disability Certificate as applicable for claiming reservation.
- 6. Any other document mentioned in the Notification / Prospectus.
- 7. Two Passport size photographs.

An authorized representative can appear for the counselling on behalf of those candidates who cannot appear in person under inevitable circumstances. The representative should bring an authorization letter as given in *annexure I* while appearing for the counselling.

General

- 1. Applications received incomplete, delayed and/or without the chalan receipt for Rs.300/- will be rejected without notice.
- 2. Enquiry regarding the receipt of application will not be entertained.
- 3. Fees mentioned in the Prospectus are subject to revision.
- 4. University has the right to make changes in the examination schedule notified.
