



TERMS AND CONDITIONS –DRIVE HOME YOUR DREAM CAR COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS “**DRIVE HOME YOUR DREAM CAR COMPETITION**”. BY PROCEEDING WITH PLAYING THE **DRIVE HOME YOUR DREAM CAR COMPETITION**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms and Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE **DRIVE HOME YOUR DREAM CAR COMPETITION**.

Terms and Conditions

1. “**DRIVE HOME YOUR DREAM CAR COMPETITION**” (hereinafter referred to as the “**Competition**”) is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (“**OnMobile**” or “**Organizer**”) for enabling active subscribers, who use the Vodafone India Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in the Competition, pre-paid or post-paid category of Subscribers who are the rightful user of the Vodafone India connection, in whose name the mobile phone connection number (“**MSISDN**”) is registered with Vodafone India (hereinafter referred to as “**Subscriber(s)**”) as specified in Circles stated in Clause 2 herein, of either Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter individually or collectively referred to as “**Vodafone India**”) to participate in the Competition. In the event the MSISDN is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the terms applicable for the Competition. The Competition is open to Subscribers during the period from **14th February 2015, 00:00:01 hrs to 14th May 2015, 23:59:59 hrs**, both days inclusive (hereinafter referred to as the “**Competition Period**”). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit.
2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles (“**Circle(s)**”) of ANDHRA PRADESH, ASSAM, NORTH EAST, BIHAR, DELHI, JAMMU & KASHMIR, GUJARAT, HARYANA, KARNATAKA, KERALA, MAHARASTRA, MADHYA PRADESH, ORISSA, MUMBAI, PUNJAB, HIMACHAL



PRADESH, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, KOLKATA, WEST BENGAL, CHENNAI and TAMIL NADU. Notwithstanding the foregoing, if the operation of or participation in the Competition is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or participate in the Competition. No further notice shall be given by the Organizer or Vodafone India, in this regard.

3. Eligibility

This Competition is open for participation for all Subscribers who fulfil the following criteria:

1. He/she must be of or above 18 years of age;
 2. He/she must be a resident of India;
 3. He/she must belong to any one of the Circles mentioned herein;
 4. He/she must be an active Subscriber;
 5. He/she must not have been the subject of any criminal proceeding;
 6. He/she must not have been either convicted and / or prosecuted for commission of any criminal offence nor be of an unsound mind; and
 7. He/she must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.
- This Competition is open to all Vodafone India active Subscribers. Any active Subscriber playing this Competition shall be referred to as a **“Participant”** throughout these Terms and Conditions.
 - For the purposes of these Terms and Conditions, wherever the context so requires **“You”** or **“Your”** shall mean any natural person who is a Participant.

Also, by participating in this Competition, You:

- Agree to the Terms and Conditions mentioned below and give Your consent for the same;
- Agree that You are entering into this Competition as an independent party and nothing herein establishes an employer-employee relationship between You and Vodafone India or between You and OnMobile and You are acting voluntarily, using Your own time and resources to participate in this Competition, solely at Your own risk;
- Warrant that You have read understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to playing this Competition, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.
- Confirm and undertake that You will make an informed choice regarding the option to play through voice on Interactive Voice Response (**“IVR”**) or Out Bound Dialer, Short Message Service (**“SMS”**) or on Unstructured Supplementary Service Data (**“USSD”**) and after understanding the implications of the same.



The Competition will be available in the below mentioned languages:

English, Hindi, Gujarati, Marathi, Punjabi, Bengali, Malayalam, Telugu, Kannada, Oriya and Tamil on IVR ("**Interactive Voice Response**") and in English and Hinglish languages on Short Message Service ("**SMS**").

A Participant, by participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the Winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer or Vodafone India, its affiliates and associates or for any reason whatsoever. Participants who are roaming outside their home Circle will be barred from playing the Competition.

- Further, the Participants who are chosen as Winners of each category of prizes in accordance with the Winner selection process under the Terms and Conditions of the Competition shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the players using such mobile number ("**Winner(s)**"). If the Winner is not able to provide sufficient evidence to show that he/she is the Subscriber of the mobile connection, the Organizer reserves the right to award the prize to the next eligible Winners or to forfeit the prize, at its sole discretion.

The Terms and Conditions can be amended or varied from time to time or withdrawn without prior notice to You and therefore, please visit the Website to keep Yourself updated and informed.

5. **Charging:**

- The questions in the Competition are divided into 10 sets ("**Set(s)**") having different number of questions in each Set. All Participants of the Competition will be charged as follows depending upon the mode of playing the Competition chosen by them:

(i) Participation in the Competition through IVR and OBD:

Each Participant shall be charged Rs 3/- per answer, while playing the Competition on IVR, by calling the toll-free number 5670330 or 567035 or 56703, unless otherwise specified herein.

(ii) Participation in the Competition through SMS:

Each Participant shall be charged Rs 3/- per SMS sent to the number 5670330 during the Competition Period, unless otherwise specified herein.



(iii) Participation in the Competition through USSD:

Each Participant shall be charged Rs 3/- per input sent to the number *567*7# during the Competition Period, unless otherwise specified herein.

(iv) A Participant will be charged only if he/she plays the Competition, in accordance with these Terms and Conditions. There will not be any automatic deduction of charges for this Competition.

(iv) The charged amount will not be refunded to Participants under any circumstances.

6. Questions and Scoring

- The Competition consists of 750 questions with 2 answer options each.
- All questions under this Competition shall be based on information available to the public at large.
- Set 1 will consist of 5 questions, Set 2 will consist of 10 questions, Set 3 will consist of 15 questions, Set 4 will consist of 20 questions, Set 5 will consist of 30 questions, Set 6 will consist of 50 questions, Set 7 will consist of 100 questions, Set 8 will consist of 170 questions, Set 9 will consist of 200 questions and Set 10 will consist of 150 questions, which may be played by the Participants.
- All Participants may choose to play all questions at once, else he/she can continue playing the questions on any of the days during the Competition Period.
- For every right answer the Participant will get 1 point. There is no negative marking for a wrong answer.
- The Participant will be sent the questions one after the other till he/she finishes answering all the questions of the Competition.
- The Competition can be played only once by a Participant.

7. Competition on Voice

- Competition will be available on the toll-free numbers 5670330, 567035 and 56703.
- All the Participants can play the Competition by calling the toll-free numbers 5670330 or 567035 or 56703. To unsubscribe from the competition, the participants may send STOP to 5670330.
- Participants will be informed of the rules, prizes to be won and Terms and Conditions URL of the Competition on calling any of the aforementioned numbers..
- Participants may send PRI, RUL, SCORE or TNC as an SMS to 5670330, without additional charges for such SMS's, to know about the details of the prizes applicable under this Competition,



applicable rules and Terms and Condition URL and current total score of the Participant in all the Sets respectively.

- Participants can press * to listen to a question again.
- Participants can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.
- Once the Participant presses 1 or 2 on his/her mobile phone keypad as his/her answer for the relevant question, Rs. 3/- shall be immediately charged. If the charging is unsuccessful, the Participant will be informed about such unsuccessful charging. Such answer of the Participant for which the Participant has not been charged shall be disregarded for the purpose of Winner selection and such question will remain as an unanswered question which may be given to the Participant again sometime during the Competition Period.

8. Competition on SMS:

- Participants can play this Competition on SMS, by sending WIN or GO or YES or CAR GOLD or any other keyword except STOP, PRI, RUL, TNC and SCORE as an SMS to the toll free number 5670330.
- For all Participants who are participating in the Competition for the first time, a welcome SMS will be sent to the number of the Participant registered with Vodafone India, informing him/her about the prizes to be won and the URL of the Terms and Conditions. After completion of each Set of questions, a welcome SMS will be sent to the number of the Participants introducing them to the relevant subsequent Set, prizes to be won in that Set and the charging amount for that Set.
- A Participant shall be charged Rs 3/- for every SMS sent to the number 5670330, unless otherwise mentioned. If a Participant has not been charged for a particular question, the answer to such uncharged question shall be disregarded for the purposes of Winner selection. An SMS will be sent to the number of the Participant registered with Vodafone India informing him of such unsuccessful charging and such question will remain as an unanswered question and may be given to the Participant again sometime during the Competition Period.

- After every right or wrong answer, the Participant will be sent an appropriate SMS on his/her number registered with Vodafone India with his/her updated score and given the next question and answer options.
- If Participant stops playing after answering the nth question then when he/she sends an SMS to 5670330, he/she will get the (n+1)th question.



- If a Participant does not receive the (n+1)th question after answering the nth question, for any reason whatsoever, then when he/she sends the keyword 'WIN' or 'GO' or 'YES' or 'CAR' or 'GOLD' on the number 5670330, he/she will be sent the (n+1)th question on his/her number registered with Vodafone India.
- If a Participant stops playing the Competition after answering the nth question then he /she will be sent a reminder SMS on his/her number registered with Vodafone India at periodic intervals from the time he/she stops playing the Competition and the Participant hereby consents to receiving such reminder SMS's, without any further claims. In the event a Participant does not play the Competition for a continuous period of 25 (twenty five) days from the date of the last answer received by the Organiser under any Set, the Organiser shall not send further reminder messages to such MSISDN of the Participant.

9. Competition on USSD:

- All Participants may play the Competition by dialing the Unstructured Supplementary Service Data ("USSD") string *567*7#. If a Participant dials the USSD string *567*7# for the first time, a Welcome SMS will be sent to that MSISDN of the Participant registered with Vodafone India, informing the Participant about the charges and prizes to be won and the link for the Terms and Conditions.
- This will be followed by question and answer options on USSD channel.
- All the questions have 2 answer options each and participants can answer by sending 1 or 2, as a response to the questions.

- After every right or wrong answer, the Participant will be sent one USSD message with the right or wrong answer response, along with the score details and the next question and answer options.



- In case of an invalid USSD input by the Participant, the Participant is sent a message on USSD stating that the input provided by him/her is invalid and will contain details of how to answer the question correctly. This will be followed by another question and answer options.
- If a Participant stops playing after answering the nth question then when he/she dials USSD string *567*7# again, he/she will get the (n+1)th question on USSD.
- The Participant is given the questions one after the other till he/she finishes answering all the questions.
- Once the Participant answers all the questions, an exit message will be sent as a USSD. The same will happen if the Participant dials USSD string after he/she has answered all the questions or if he/she tries to answer a question after having answered all the questions.

10. Competition on OBD

Competition will be available for playing on OBD. Once the Participant has successfully been accepted as a participant to the Competition, a welcome prompt is played to the Participant that introduces him/her to the Competition.

Participants will be informed of the rules, prizes to be won and Terms and Conditions URL of the Competition on the OBD.

Participants may send PRI, RUL, SCORE or TNC as an SMS to 5670330, without additional charges for such SMS's, to know about the details of the prizes applicable under this Competition, applicable rules and Terms and Condition URL and current total score of the Participant in all the Sets respectively.

Participants can press * to listen to a question again.

Participants can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.

Once the Participant presses 1 or 2 on his/her mobile phone keypad as his/her answer for the relevant question, Rs. 3/- shall be immediately charged. The winning MSISDN will be removed from the list of eligible MSISDNs for the 1st Prize, 2nd Prize, and 3rd Prize.

1st Prize:-
