#### 2. <u>CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES</u>:

The contract amount shall be paid an amount equivalent to last pay & allowances drawn less the initial amount of Pension fixed before commutation plus relief etc. payable thereon or Rs. 25,000/-p.m. whichever is higher. Further a lump sum amount of Rs. 8000/-p.m. shall be paid towards Mobile, Conveyance etc. However, the condition of "Last Pay & Allowance drawn by the Officer less the initial amount of pension fixed before commutation plus relief etc." will be applicable only to the pension co-optee retired bank official of a Nationalised Bank and in case of non-pensioner, the candidate will be eligible only for Rs. 25,000/-p.m. together with lump sum amount of Rs. 8,000/-towards Mobile, Conveyance etc. Please note that no other benefits or charges shall accrue or be payable.

Reimbursement of TA/DA for traveling as per requirement of the post shall be made as per the scale / grade in which he/she was working at the time of his/her superannuation. No other allowances / reimbursement of expenses will be admissible.
